Iowa Code § 96.3(7) – Recovery of Benefit Overpayment

STATEMENT OF THE CASE:

Claimant filed an appeal from the October 19, 2022 (reference 04) unemployment insurance decision that found claimant was overpaid benefits of \$481.00 between March 28, 2021 and May 8, 2021 because he incorrectly reported wages earned from In'tveld's Enterprises (employer). The parties were properly notified of the hearing. A telephone hearing was held on November 17, 2022. Claimant participated. Employer participated through Aric Bradley, Human Resources Manager. No exhibits were admitted. Official notice was taken of the administrative record.

ISSUES:

Whether claimant is totally, partially or temporarily unemployed.
Whether claimant correctly reported wages earned.
Whether claimant is eligible for benefits based on wages earned.
Whether claimant is overpaid UI benefits.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

Claimant filed an initial claim for unemployment benefits effective February 7, 2021 and ongoing weekly claims between February 7, 2021 and June 12, 2021. Claimant's weekly benefit amount was \$512.00.

For the two benefit weeks between March 28, 2021 and April 10, 2021, claimant earned no wages, reported no wages on his weekly claim and received a full benefit payment of \$512.00

Between April 11, 2021 and April 17, 2021, claimant worked for employer and earned wages of \$104.00 and received tips of \$99.00. For the benefit week ending April 17, 2021, claimant reported that he earned gross wages of \$60.00 and received a full unemployment benefit payment of \$512.00.

For the two benefit weeks between April 18, 2021 and May 1, 2021, claimant earned no wages, reported no wages on his weekly claim and received a full benefit payment of \$512.00.

Between May 2, 2021 and May 8, 2021, claimant worked for employer and earned wages of \$186.00 and received tips of \$277.00. For the benefit week ending May 8, 2021, claimant reported that he earned gross wages of \$100.00 and received a full unemployment benefit payment of \$512.00.

On October 19, 2022, IWD issued a decision (reference 04) finding claimant was overpaid UI benefits of \$481.00 for three weeks between March 28, 2021 and May 8, 2021 because he failed to report wages earned with employer In'tveld's Enterprises.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes:

Iowa Code section 96.3(7) states:

7. Recovery of overpayment of benefits.

a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

Iowa Code section 96.5(5) provides:

An individual shall be disqualified for benefits, regardless of the source of the individual's wage credits:

5. Other compensation.

a. For any week with respect to which the individual is receiving or has received payment in the form of any of the following:

(1) Wages in lieu of notice, separation allowance, severance pay, or dismissal pay.

(2) Compensation for temporary disability under the workers' compensation law of any state or under a similar law of the United States.

(3) A governmental or other pension, retirement or retired pay, annuity, or any other similar periodic payment made under a plan maintained or contributed to by a base period or chargeable employer where, except for benefits under the federal Social Security Act or the federal Railroad Retirement Act of 1974 or the corresponding provisions of prior law, the plan's eligibility requirements or benefit payments are affected by the base period employment or the remuneration for the base period employment. However, this subparagraph shall only be applicable if the base period employer has made one hundred percent of the contribution to the plan.

b. Provided, that if the remuneration is less than the benefits which would otherwise be due under this chapter, the individual is entitled to receive for the week, if otherwise eligible, benefits reduced by the amount of the remuneration. Provided further, if benefits were paid for any week under this chapter for a period when benefits, remuneration or compensation under paragraph "a", subparagraph (1), (2), or (3), were

paid on a retroactive basis for the same period, or any part thereof, the department shall recover the excess amount of benefits paid by the department for the period, and no employer's account shall be charged with benefits so paid. However, compensation for service-connected disabilities or compensation for accrued leave based on military service by the beneficiary with the armed forces of the United States, irrespective of the amount of the benefit, does not disqualify any individual otherwise qualified from any of the benefits contemplated herein. A deduction shall not be made from the amount of benefits payable for a week for individuals receiving federal social security pensions to take into account the individuals' contributions to the pension program.

Iowa Code section 96.3(3) provides:

3. Partial unemployment. An individual who is partially unemployed in any week as defined in section 96.1A, subsection 37, paragraph "b", and who meets the conditions of eligibility for benefits shall be paid with respect to that week an amount equal to the individual's weekly benefit amount less that part of wages payable to the individual with respect to that week in excess of one-fourth of the individual's weekly benefit amount. The benefits shall be rounded to the lower multiple of one dollar.

During the weeks in which claimant earned no wages, he was totally unemployed and entitled to a full benefit payment.

For the weeks ending April 17, 2021 and May 8, 2021, claimant worked but earned less than \$527.00 (his weekly benefit amount of \$512.00 plus \$15.00). Therefore, claimant was partially unemployed and was entitled to partial benefit payments according to the following formula:

$$\begin{aligned} \$ (\text{wages}) - \$ (25\% \text{ of WBA}) &= \$ (\text{wage deduction}) \\ \$ (\text{WBA}) - \$ (\text{wage deduction}) &= \$ (\text{partial weekly benefit amount}) \end{aligned}$$

The following chart reflects the benefits claimant received, the benefits claimant was entitled to and the resulting underpayment or overpayment:

Claimant was overpaid benefits of \$410.00 for two weeks between March 28, 2021 and May 8, 2021 because he failed to correctly report wages from In'tveld's Enterprises. Claimant is required to repay those benefits.

DECISION:

The October 19, 2022 (reference 04) unemployment insurance decision is MODIFIED IN FAVOR OF APPELLANT. Claimant is overpaid benefits of \$410.00 for two weeks between March 28, 2021 and May 8, 2021; those benefits must be repaid.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
