## STATEMENT OF THE CASE:

The claimant/appellant, Jennifer Hamilton, filed an appeal from the August 3, 2022 (reference 02) unemployment insurance decision which found claimant was overpaid \$9,000.00 in FPUC benefits for the fifteen week period between March 29, 2020 and July 25, 2020 because she failed to accurately report earnings and imposed \$1,350.00 15% fraud penalty and administrative penalty due to misrepresentation. The claimant's FPUC fraud overpayment for this time period was calculated at \$10,350.00.

The parties were properly notified of the hearing. A telephone hearing was held on October 7, 2022. Claimant Jennifer Hamilton participated and testified. John Gipson appeared as the hearing representative for the claimant. Iowa Workforce Development (IWD) appeared through Jennifer Vogt, Investigator and Jeffrey Konscol, Attorney for IWD. Department Exhibits 1-9. were admitted. Claimant's exhibit A, B, C, were admitted. Official notice was taken of the administrative record.

## **ISSUES:**

Whether claimant was FPUC benefits. Whether a penalty for misrepresentation was properly imposed.

## FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

Claimant filed an initial claim for benefits effective March 15, 2020. Claimant field ongoing weekly claims for the fifty-week period between March 28, 2020 and March 13, 2021 and received unemployment insurance (UI) and FPUC benefits each week.

On August 3, 2022, IWD issued a decision (reference 01) that found claimant was not eligible for UI benefits from March 22, 2020 through March 13, 2021 because she incorrectly reported wages. That decision has been affirmed with a minor reduction in net overpayment that does not effect the calculations herein. (see appeal number 22A-UI-16021-JD-T).

The administrative law judge further found that claimant did willfully or knowingly misreport wages earned on weekly claims and that the 15% Fraud Penalty and Administrative Penalty were properly imposed. Those findings are incorporated herein by reference. (See appeal 22A-UI-16021-JD-T). The administrative law judge's decision remains in effect.

Claimant received FPUC benefits in the amount of \$9,000 for the fifteen-week period between March 29, 2020 and July 25, 2020.

# REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes:

PL 116-136, Sec. 2104 provides, in pertinent part:

(b) Provisions of Agreement

(1) Federal pandemic unemployment compensation.--Any agreement under this section shall provide that the State agency of the State will make payments of regular compensation to individuals in amounts and to the extent that they would be determined if the State law of the State were applied, with respect to any week for which the individual is (disregarding this section) otherwise entitled under the State law to receive regular compensation, as if such State law had been modified in a manner such that the amount of regular compensation (including dependents' allowances) payable for any week shall be equal to

(A) the amount determined under the State law (before the application of this paragraph), plus

(B) an additional amount of \$600 (in this section referred to as "Federal Pandemic Unemployment Compensation").

. . .

(f) Fraud and Overpayments

. . .

(2) Repayment.--In the case of individuals who have received amounts of Federal Pandemic Unemployment Compensation to which they were not entitled, the State shall require such individuals to repay the amounts of such Federal Pandemic Unemployment Compensation to the State agency, except that the State agency may waive such repayment if it determines that—

(A) the payment of such Federal Pandemic Unemployment Compensation was without fault on the part of any such individual; and

(B) such repayment would be contrary to equity and good conscience.

The decision that denied claimant UI benefits remains in effect. Because claimant is not eligible for UI benefits, claimant is also not eligible for FPUC benefits. Therefore, claimant has received FPUC benefits to which claimant was not entitled. The administrative law judge concludes that claimant has been overpaid FPUC benefits in the amount outlined in the findings of fact above. Those benefits must be recovered in accordance with lowa law.

The next issue to be determined is whether the imposition of a 15% penalty due to fraud is warranted. For the reasons that follow, the administrative law judge concludes:

PL 116-136 Sec 2104(f) provides in pertinent part:

EMERGENCY INCREASE IN UNEMPLOYMENT COMPENSATION BENEFITS.

(f) FRAUD AND OVERPAYMENTS. - (1) IN GENERAL. -

If an individual knowingly has made, or caused to be made by another, a false statement or representation of a material fact, or knowingly has failed, or caused another to fail, to disclose a material fact, and as a result of such false statement or representation or of such nondisclosure such individual has received an amount of Federal Pandemic Unemployment Compensation to which such individual was not entitled, such individual –

(A) shall be ineligible for further Federal Pandemic Unemployment Compensation in accordance with the provisions of the applicable State unemployment compensation law relating to fraud in connection with a claim for unemployment compensation; and

(B) shall be subject to prosecution under section 1001 of title 18, United States Code.

The Department of Labor has provided the following guidance regarding penalties for fraud:

Within the context of the CARES Act, states must apply a minimum 15 percent monetary penalty to an individual's overpayment when the state determines that such an overpayment was made to an individual due to fraud. Fraud includes instances where an individual knowingly made, or caused to be made, a false statement or representation of a material fact, or knowingly has failed, or caused another to fail, to disclose a material fact. This fraud penalty is applicable to ... FPUC

UIPL No. 20-21, pages 4-5.

The Department of Labor further explains: "eligibility fraud occurs when benefits or services are acquired as a result of false information being provided with the intent to receive benefits for which an individual would not otherwise be eligible." UIPL No. 20-21, Change 1, page 7.

Claimant did willfully or knowingly misreport wages earned on their weekly claims. The claimant testified to knowing what earnings constituted gross earnings each week but was unable to explain why she consistently underreported her wages. Therefore, the 15% penalty due to fraud and the administrative penalty is warranted.

# **DECISION:**

The August 3, 2022 (reference 02) unemployment insurance decision is AFFIRMED. Claimant was overpaid FPUC benefits in the amount of \$9,000.00, which must be repaid. Therefore, the 15% penalty of \$1,350.00 due to fraud and the administrative penalty is warranted. The claimant's total fraud overpayment for this time period is \$10,350.00.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final.
