Section 96.3-5 - Business Closure

STATEMENT OF THE CASE:

Russ C. Prather filed a timely appeal from an unemployment insurance decision dated May 13, 2004, reference 02, which denied his request for redetermination of his unemployment insurance claim based upon the business closure provisions of the statute. Due notice was issued for a telephone hearing to be held June 25, 2004. Because of a document submitted by Twister Chassis, LLC, identified for the record is Exhibit D-1, no additional evidence is necessary.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: Prior to filing his present unemployment insurance claim, Russ C. Prather was last employed by Twister Chassis, LLC in Knoxville, Iowa. That business is now permanently closed.

REASONING AND CONCLUSIONS OF LAW:

The question is whether it is appropriate to redetermine the claimant's benefits using the business closure provisions of the statute. It is.

lowa Code Section 96.3-5 allows redetermination of a claimant's benefits if the claimant's last employer has gone out of business at the location where the claimant was employed. The evidence in this record establishes that those conditions have been met. Therefore, redetermination is appropriate.

DECISION:

The unemployment insurance decision dated May 13, 2004, reference 02, is reversed. The claimant's benefits shall be redetermined using the business closure provisions of the Employment Security Law.
