**STATEMENT OF THE CASE:**

On May 6, 2024, the claimant, Patti Tyler, filed an appeal from the April 17, 2024 (reference 13) unemployment insurance decision that denied benefits effective April 7, 2024, based on the determination that the claimant did not report to Iowa Workforce Development (IWD) as directed. After due notice was issued, a telephone hearing was held on May 22, 2024. Appeal numbers 24A-UI-04424-PT-T, 24A-UI-04425-PT-T, 24A-UI-04428-PT-T, 24A-UI-04429-PT-T, 24A-UI-04430-PT-T, 24A-UI-04431-PT-T, and 24A-UI-04432-PT-T were heard together and created one record. Ms. Tyler participated personally. The administrative law judge took official notice of the administrative record.

**ISSUE:**

Whether the claimant's appeal is timely.

**FINDINGS OF FACT:**

Having reviewed the evidence in the record, the administrative law judge finds: Iowa Workforce Development (IWD) mailed the reference 13 unemployment insurance decision to the claimant's address of record on April 17, 2024. The claimant received the decision, but she could not recall precisely when she received it.

The decision contained a warning that an appeal must be postmarked or received by the Appeals Bureau by April 29, 2024. The claimant electronically submitted her appeal on May 6, 2024, as evidenced by the date stamp on the appeal. At the hearing, the claimant did not provide a specific reason as to why the appeal was untimely. However, the claimant indicated that she found the process confusing, was initially unsure about the appeal process, and waited so that she could discuss the decision with IWD representatives at her local office before filing the appeal.

## REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the claimant's appeal was untimely.

Iowa Code § 96.6(2) provides, in pertinent part: “[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision.”

Iowa Admin. Code r. 871-24.35(1) provides:

1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:

(a) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.

(b) If transmitted via the State Identification Data Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.

(c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also, *In re Appeal of Elliott* 319 N.W.2d 244, 247 (Iowa 1982). The question in this case thus becomes whether the appellant was deprived of a reasonable opportunity to assert an appeal in a timely fashion. *Hendren v. IESC*, 217 N.W.2d 255 (Iowa 1974); *Smith v. IESC*, 212 N.W.2d 471, 472 (Iowa 1973).

The weight of the evidence indicates that the April 17, 2024 (reference 13) unemployment insurance decision was delivered to the claimant's address of record in a timely manner, prior to the April 29, 2024, extended appeal deadline, but the claimant did not submit her appeal until after the deadline. The claimant's delay was not due to agency error or misinformation or delay of the United States Postal Service pursuant to Iowa Administrative Code rule 871-24.35(2). No other good-cause reason has been established for the delay. The claimant's appeal was not

filed on time and the administrative law judge lacks jurisdiction to make a determination with respect to the nature of the appeal or to disturb the decision from which the claimant appeals.

**DECISION:**

The April 17, 2024, (reference 13) unemployment insurance decision that denied benefits effective April 7, 2024, based on the determination that the claimant did not report to Iowa Workforce Development as directed is affirmed. The claimant's appeal is not timely and the decision of the representative remains in effect.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

**AN APPEAL TO THE BOARD SHALL STATE CLEARLY:**

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2. Si nadie presenta una apelación de la decisión del juez ante la Junta de Apelaciones Laborales dentro de los quince (15) días, la decisión se convierte en acción final de la agencia y usted tiene la opción de presentar una petición de revisión judicial en el Tribunal de Distrito dentro de los treinta (30) días después de que la decisión adquiriera firmeza.
