Section 96.3-7 - Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

The claimant appealed an unemployment insurance decision dated March 8, 2005, reference 02, that concluded he was overpaid \$430.00 in unemployment insurance benefits. A telephone hearing was held on April 4, 2005. Proper notice of the hearing was given to the claimant. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the following findings of fact, reasoning and conclusions of law, and decision are entered.

FINDINGS OF FACT:

The claimant filed a new claim for unemployment insurance benefits with an effective date of January 30, 2005. His weekly benefit amount was determined to be \$381.00. For the week ending February 12, 2005, the claimant worked and earned \$297.00 in wages. At the end of the week, the claimant filed a weekly claim but did not report any wages because he

understood that the wages were to be reported when paid. He was paid a total of \$381.00 in benefits for the week. For the week ending February 19, 2005, the claimant worked and earned \$442.00 in wages. At the end of the week, the claimant filed a weekly claim and reported \$248.00 wages, which were his net wages from the previous week. He was paid a total of \$228.00 in benefits for the week.

REASONING AND CONCLUSIONS OF LAW:

The issue in this case is whether the claimant was overpaid unemployment insurance benefits.

Iowa Code section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

The law states that a claimant who earns less than his weekly benefit amount plus \$15.00 is entitled to partial unemployment insurance benefits in an amount equal to the weekly benefit amount minus that part of wages payable in excess of one-fourth of the individual's weekly benefit amount. Iowa Code sections 96.3-3 and 96.19-38-b.

As a result, the claimant was entitled to \$179.00 for the week ending February 12, 2005, and was not entitled to any benefits for the week ending February 19, 2005. He was overpaid a total of \$430.00.

DECISION:

The unemployment insurance decision dated March 8, 2005, reference 02, is affirmed. The claimant was overpaid \$430.00 in unemployment insurance benefits.
