### STATEMENT OF THE CASE:

The claimant filed a timely appeal from an unemployment insurance decision dated March 31, 2004, reference 03, which ruled that he had been overpaid \$75.00 for the week ending March 27, 2004. Due notice was issued for a telephone hearing to be held April 21, 2004. At the time of the hearing, the claimant requested that it be withdrawn.

### FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: The claimant, the appellant in this matter, has requested that the appeal be withdrawn.

## REASONING AND CONCLUSIONS OF LAW:

A rule found 871 IAC 26.8(1) allows the administrative law judge to grant an appellant's request for the withdrawal of its appeal. A review of all matters of record persuades the administrative law judge that it is appropriate to allow the withdrawal of this appeal.

# **DECISION:**

The unemployment insurance decision dated March 31, 2004, reference 03, remains in effect. The claimant was overpaid by \$75.00 for the week ending March 27, 2004. All of the payments have been recovered. The claimant owes nothing to the Agency at this time.
