Section 96.4-3 - Active Work Search

# STATEMENT OF THE CASE:

The claimant filed a timely appeal from an unemployment insurance decision dated March 9, 2004, reference 03, which issued a warning to the claimant based upon a finding that the claimant had not performed an active work search for the week ending March 6, 2004. After reviewing the claimant's appeal letter and Agency benefit payment records, the administrative law judge concludes that no additional testimony is necessary.

### FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: During the week ending March 6, 2004, Martin L. Bain made one in person job contact. That contact resulted in Mr. Bain being hired.

# REASONING AND CONCLUSIONS OF LAW:

The question is whether the warning should be removed from the claimant's record. For the reasons which follow, the administrative law judge concludes that it should.

Since Mr. Bain's single job contact during the week in question resulted in his being hired, the active work search provision of the statute has been met. The warning shall be removed.

# **DECISION:**

The unemployment insurance decision dated March 9, 2004, reference 03, is reversed. The warning is removed from the claimant's record.
