Iowa Code § 96.3-7 - Recovery of Overpayment of Benefits

**STATEMENT OF THE CASE:**

Claimant Kyle B. Higgins timely appealed a representative's decision dated March 17, 2023, (reference 28) that concluded the claimant was overpaid unemployment insurance benefits as a result of a disqualification decision. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on April 11, 2023. The following appeals were consolidating into one hearing: UI-03198-S2-T, 23A-UI-03199-S2-T, 23A-UI-03200-S2-T, 23A-UI-03201-S2-T, 23A-UI-03202-S2-T, 23A-UI-03203-S2-T, 23A-UI-03204-S2-T, 23A-UI-03205-S2-T, 23A-UI-03206-S2-T, 23A-UI-03207-S2-T, 23A-UI-03208-S2-T, 23A-UI-03209-S2-T, 23A-UI-03210-S2-T, 23A-UI-03211-S2-T, 23A-UI-03212-S2-T, 23A-UI-03213-S2-T, 23A-UI-03214-S2-T, 23A-UI-03215-S2-T, 23A-UI-03216-S2-T, 23A-UI-03217-S2-T, 23A-UI-03218-S2-T, 23A-UI-03219-S2-T, 23A-UI-03220-S2-T, 23A-UI-03221-S2-T, 23A-UI-03222-S2-T, 23A-UI-03223-S2-T and 23A-UI-03224-S2-T. Claimant participated personally. Department's Exhibit D-1 was received. The administrative law judge took official notice of the administrative record.

**ISSUE:**

The issue is whether the claimant is overpaid unemployment insurance benefits.

**FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds: On March 6, 2023, Iowa Workforce Development (IWD) issued a decision (reference 14) that denied claimant regular state unemployment insurance (UI) benefits. That decision has been affirmed. See 23A-UI-03207-S2-T. Claimant did receive benefits in the gross amount of \$260.00 for the one-week period ending January 7, 2023.

**REASONING AND CONCLUSIONS OF LAW:**

For the following reasons the administrative law judge concludes the claimant was overpaid unemployment insurance benefits.

Iowa Code § 96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.


a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5. The employer shall not be relieved of charges if benefits are paid because the employer or an agent of the employer failed to respond timely or adequately to the department's request for information relating to the payment of benefits. This prohibition against relief of charges shall apply to both contributory and reimbursable employers. If the department determines that an employer's failure to respond timely or adequately was due to insufficient notification from the department, the employer's account shall not be charged for the overpayment.

The administrative law judge concludes that the claimant has been overpaid unemployment insurance benefits in the amount of \$260.00 pursuant to Iowa Code § 96.3(7) as the disqualification decision that created the overpayment decision has been affirmed.

**DECISION:**

The decision of the representative dated March 17, 2023, (reference 28) is affirmed. The claimant was overpaid regular state unemployment insurance benefits in the amount of \$260.00 to which he was not entitled, and those benefits must be recovered in accordance with the law.

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

**AN APPEAL TO THE BOARD SHALL STATE CLEARLY:**

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
