Section 96.5-7 - Vacation Pay

STATEMENT OF THE CASE:

Claimant appealed a representative's decision dated August 6, 2004, reference 02, that concluded claimant was ineligible for the two weeks ending July 17, 2004 for unemployment insurance benefits in the amount of \$644.00. A telephone hearing was scheduled and held on September 1, 2004, pursuant to due notice. Claimant did participate. Employer failed to participated. Exhibits A, B and C were received into evidence.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant's employment with employer was separated on June 30, 2004, and claimant received

commission pay in the amount of \$4,500.00 based upon work performed in June of 2004. Claimant did not receive any vacation pay. The employer made a mistake in reporting wages as vacation pay. Claimant also reported vacation pay for the week ending July 24, 2004 due to the employer's error in reporting of wages. Employer did designate the period of time to which the vacation pay was to be applied in error.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes that vacation pay was not deducted for the correct period.

Iowa Code Section 96.5-7 provides:

An individual shall be disqualified for benefits: ...

- 7. Vacation pay.
- a. When an employer makes a payment or becomes obligated to make a payment to an individual for vacation pay, or for vacation pay allowance, or as pay in lieu of vacation, such payment or amount shall be deemed "wages" as defined in section 96.19, subsection 41, and shall be applied as provided in paragraph "c" hereof.
- b. When, in connection with a separation or layoff of an individual, the individual's employer makes a payment or payments to the individual, or becomes obligated to make a payment to the individual as, or in the nature of, vacation pay, or vacation pay allowance, or as pay in lieu of vacation, and within ten calendar days after notification of the filing of the individual's claim, designates by notice in writing to the department the period to which the payment shall be allocated; provided, that if such designated period is extended by the employer, the individual may again similarly designate an extended period, by giving notice in writing to the department not later than the beginning of the extension of the period, with the same effect as if the period of extension were included in the original designation. The amount of a payment or obligation to make payment, is deemed "wages" as defined in section 96.19, subsection 41, and shall be applied as provided in paragraph "c" of this subsection 7.
- c. Of the wages described in paragraph "a" (whether or not the employer has designated the period therein described), or of the wages described in paragraph "b", if the period therein described has been designated by the employer as therein provided, a sum equal to the wages of such individual for a normal workday shall be attributed to, or deemed to be payable to the individual with respect to, the first and each subsequent workday in such period until such amount so paid or owing is exhausted. Any individual receiving or entitled to receive wages as provided herein shall be ineligible for benefits for any week in which the sums, so designated or attributed to such normal workdays, equal or exceed the individual's weekly benefit amount. If the amount so designated or attributed as wages is less than the weekly benefit amount of such individual, the individual's benefits shall be reduced by such amount.
- d. Notwithstanding contrary provisions in paragraphs "a", "b", and "c", if an individual is separated from employment and is scheduled to receive vacation payments during the period of unemployment attributable to the employer and if the employer does not designate the vacation period pursuant to paragraph "b", then payments made by the

employer to the individual or an obligation to make a payment by the employer to the individual for vacation pay, vacation pay allowance or pay in lieu of vacation shall not be deemed wages as defined in section 96.19, subsection 41, for any period in excess of one week and such payments or the value of such obligations shall not be deducted for any period in excess of one week from the unemployment benefits the individual is otherwise entitled to receive under this chapter. However, if the employer designates more than one week as the vacation period pursuant to paragraph "b", the vacation pay, vacation pay allowance, or pay in lieu of vacation shall be considered wages and shall be deducted from benefits.

e. If an employer pays or is obligated to pay a bonus to an individual at the same time the employer pays or is obligated to pay vacation pay, a vacation pay allowance, or pay in lieu of vacation, the bonus shall not be deemed wages for purposes of determining benefit eligibility and amount, and the bonus shall not be deducted from unemployment benefits the individual is otherwise entitled to receive under this chapter.

Because employer did designate a time period to which the vacation pay is to apply. the entire amount was not correctly deducted from the two weeks of benefits following the separation as the pay was earned wages. Claimant as a result also reported vacation pay for the week ending July 24, 2004 which deprived him of one additional week of benefits. The week ending July 24, 2004 is not the subject of this appeal.

DECISION:

The August 6, 2004, reference 02, decision is reversed. The vacation pay was not deducted for the correct period. Claimant is not disqualified for benefits.
