STATEMENT OF THE CASE:

Latda Souravong filed a timely appeal from an unemployment insurance decision dated November 12, 2004, reference 10, which denied benefits effective November 7, 2004 upon a finding that she had failed to report to her local Workforce Development center. After due notice was issued, a telephone hearing was held December 15, 2004 with Ms. Souravong participating. This matter is considered on a consolidated record with 04A-UI-12488-AT, 04A-UI-12489-AT and 04A-UI-12490-AT. The administrative law judge takes official notice of Agency records.

FINDINGS OF FACT:

Having heard the testimony of the witness and having examined all of the evidence in the record, the administrative law judge finds: Latda Souravong participated in a telephone interview on November 10, 2004 in response to a notice which had been mailed to her a week earlier.

REASONING AND CONCLUSIONS OF LAW:

The question is whether benefits should be withheld upon the theory that Ms. Souravong failed to report as directed. The evidence clearly establishes that benefits should not be withheld for that reason. Notes of the interview are contained in the file establish that Ms. Souravong participated.

DECISION:

The unemployment insurance decision dated November 12, 2004, reference 10, is reversed.
