PL116-136, Sec. 2104 – Federal Pandemic Unemployment Compensation (FPUC) lowa Code § 96.3(7) – Recovery of Benefit Overpayment

### STATEMENT OF THE CASE:

The claimant/appellant, Hannah W. Clark, filed an appeal from the August 6, 2021 (reference 03) lowa Workforce Development ("IWD") unemployment insurance decision that concluded she was overpaid FPUC benefits for the period between May 24, 2020 and July 25, 2020. After proper notice, a telephone hearing was held on October 11, 2021. The hearing was held together with Appeals 21A-Ul-18076-JC-T and 21A-Ul-18077-JC-T. The claimant participated personally.

The administrative law judge took official notice of the administrative records. Department Exhibit D-1 was admitted. Claimant's Exhibits A and B were admitted. Based on the evidence, the arguments presented, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

## ISSUE:

Whether the claimant was overpaid FPUC benefits.

## FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant established her claim for unemployment insurance benefits with an effective date of May 10, 2020. She received \$5,400.00 in FPUC benefits between May 24, 2020 and July 25, 2020. A reference 01 decision denied benefits and that decision was affirmed in Appeal 21A-UI-18076-JC-T.

A reference 02 initial decision established an overpayment of regular unemployment insurance benefits of regular benefits in the amount \$642.00 for a three-week period between May 24, 2020 and June 13, 2020. For the same three-week period, claimant received \$1,800.00 in FPUC benefits.

### **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes the claimant has been overpaid \$1,800.00 (not \$5,400.00) in FPUC benefits.

lowa Code section 96.3(7) provides, in pertinent part:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not other wise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

PL116-136, Sec. 2104 provides, in pertinent part:

- (b) Provisions of Agreement
- (1) Federal pandemic unemployment compensation.--Any agreement under this section shall provide that the State agency of the State will make payments of regular compensation to individuals in amounts and to the extent that they would be determined if the State law of the State were applied, with respect to any week for which the individual is (disregarding this section) otherwise entitled under the State law to receive regular compensation, as if such State law had been modified in a manner such that the amount of regular compensation (including dependents' allowances) payable for any week shall be equal to
- (A) the amount determined under the State law (before the application of this paragraph), plus
- (B) an additional amount of \$600 (in this section referred to as "Federal Pandemic Unemployment Compensation").

. . . .

- (f) Fraud and Overpayments
- (2) Repayment.--In the case of individuals who have received amounts of Federal Pandemic Unemployment Compensation to which they were not entitled, the State shall require such individuals to repay the amounts of such Federal Pandemic Unemployment Compensation to the State agency...

Here, the claimant is disqualified from receiving regular unemployment insurance (UI) benefits. Accordingly, this also disqualifies claimant from receiving Federal Pandemic Unemployment Compensation (FPUC). However, the overpayment of FPUC benefits is modified to be consistent with the overpayment of regular benefits, which is for a three-week period between May 24, 2020 and June 12, 2020 only. The claimant was overpaid \$1,800.00 in Federal Pandemic Unemployment Compensation (FPUC).

This decision determines you have been overpaid FPUC under the CARES Act. If you disagree with this decision, you may file an appeal to the Employment Appeal Board by following the instructions on the first page of this decision. #### **DECISION:**

The August 6, 2021 (reference 03) initial decision is modified in favor of the claimant. The claimant has been overpaid \$1,800.00 in FPUC benefits.
