STATEMENT OF THE CASE:

Tierra Johnson, the claimant/appellant,¹ filed an appeal from the Iowa Workforce Development July 6, 2023 (reference 10) unemployment insurance (UI) decision. The decision concluded that IWD overpaid Ms. Johnson REGULAR (state) UI benefits in the total gross amount of \$765.00 for 2 weeks between February 5, 2023 and February 18, 2023 because the June 13, 2023 (reference 07) UI decision denied her UI benefits based on her voluntarily quit from employer DSS RS Companies LLC. On July 21, 2023, the Iowa Department of Inspections, Appeals, and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing to Ms. Johnson and IWD at each of their last known addresses of record for a telephone hearing scheduled for August 4, 2023.

Ms. Johnson did not call the toll-free number listed on the hearing notice at the time the hearing was scheduled to begin. IWD did not call the toll-free number listed on the hearing notice at the time the hearing was scheduled to begin. Because Ms. Johnson filed the appeal but did not call in, the undersigned administrative law judge did not hold a hearing.

ISSUE:

Should Ms. Johnson's appeal be dismissed based on her not appearing and participating?

FINDINGS OF FACT:

The DIAL UI Appeals Bureau properly notified the parties of the scheduled hearing for this appeal. Ms. Johnson did not call the toll-free number listed on the hearing notice at the time scheduled for this appeal hearing. She did not request a postponement of the hearing before the hearing date. She did not call in before the record was closed, 15 minutes after the hearing was scheduled to begin. The undersigned did not hold a hearing.

¹ Claimant is the person who filed the UI claim with IWD. Appellant is the person or employer who filed the appeal.

The hearing notice lists the hearing date of August 4, 2023, and the hearing time as 9:00 a.m. Iowa time. The hearing notice also advises parties:

IMPORTANT NOTICE!

YOU MUST CALL the toll-free number...at the time of the hearing. You may call up to 5 minutes before the hearing. You are not the organizer – Do **NOT** press 2.

The administrative law judge **WILL NOT** call you for the hearing, you **MUST** call into the number provided above to participate. Failure to participate in the hearing may result in the dismissal of your appeal. **Failure to participate in the hearing may result in dismissal of your appeal.**

The undersigned left the record open for a grace period of 15 minutes after the hearing start time, per guidance from the United States Department of Labor (DOL), to give Ms. Johnson a reasonable opportunity to participate. This reasonable amount of time is appropriate because if a hearing were conducted with the non-appealing party alone it would have likely concluded in 15 minutes or less. Holding Ms. Johnson in default for not appearing and participating during a 15-minute window after the hearing start time is reasonable considering the time allocated for each appeal hearing. Allowing this additional time period is reasonable under the circumstances.

The UI decision concluded that IWD overpaid Ms. Johnson REGULAR (state) UI benefits in the total gross amount of \$765.00 for 2 weeks between February 5, 2023 and February 18, 2023 because the June 13, 2023 (reference 07) UI decision denied her UI benefits based on her voluntarily quit from employer DSS RS Companies LLC.

REASONING AND CONCLUSIONS OF LAW:

The Iowa Administrative Procedures Act at Iowa Code § 17A.12(3) provides, in pertinent part:

If a party fails to appear or participate in a contested case proceeding after proper service of notice, the presiding officer may, if no adjournment is granted, enter a default decision or proceed with the hearing and make a decision in the absence of the party. ... If a decision is rendered against a party who failed to appear for the hearing and the presiding officer is timely requested by that party to vacate the decision for good cause, the time for initiating a further appeal is stayed pending a determination by the presiding officer to grant or deny the request. If adequate reasons are provided showing good cause for the party's failure to appear, the presiding officer shall vacate the decision and, after proper service of notice, conduct another evidentiary hearing. If adequate reasons are not provided showing good cause for the party's failure to appear, the presiding officer shall deny the motion to vacate.

Iowa Admin. Code r. 26.14(7) provides:

If a party has not responded to a notice of telephone hearing by providing the appeals bureau with the names and telephone numbers of the persons who are participating in the hearing by the scheduled starting time of the hearing or is not available at the telephone number provided, the presiding officer may proceed with the hearing. If the appealing party fails to provide a telephone number or is

unavailable for the hearing, the presiding officer may decide the appealing party is in default and dismiss the appeal as provide in Iowa Code section 17A.12(3). The record may be reopened if the absent party makes a request in writing to reopen the hearing under subrule 26.8(3) and shows good cause for reopening the hearing.

a. If an absent party responds to the hearing notice while the hearing is in progress, the presiding officer shall pause to admit the party, summarize the hearing to that point, administer the oath, and resume the hearing.

b. If a party responds to the notice of hearing after the record has been closed and any party which has participated is no longer on the telephone line, the presiding officer shall not take the evidence of the late party.

c. Failure to read or follow the instructions on the notice of hearing shall not constitute good cause for reopening the record.

Due process requires notice and an opportunity to be heard, both of which were provided to the parties. The appellant is responsible for going forward with the case in a prompt and thoughtful manner. The appellant must be present at the start of the hearing to avoid a default judgment.² The hearing notice instructs the parties to call the toll-free number listed on hearing notice at the time the hearing is scheduled to begin.

The Iowa Supreme Court has held a default should not be set aside due to the appellant's negligence, carelessness, or inattention.³ Similarly, a default should not be set aside because the appellant has ignored clear requirements in the rules. Rather, a party must show it intended to proceed with the appeal and took steps to do so, but did not appear because of some misunderstanding, accident, mistake or excusable neglect.

Ms. Johnson was not present at the start of the hearing. Per DOL guidance, the undersigned gave Ms. Johnson additional time to call-in to allow for any misunderstandings or mistakes. But she did not call in for the hearing during the additional time allotted. Ms. Johnson is in default, her appeal is dismissed, and the IWD UI decision remains in force and effect.

DECISION:

The July 6, 2023 (reference 10) UI decision concluding that IWD overpaid Ms. Johnson REGULAR (state) UI benefits in the total gross amount of \$765.00 remains in effect as she is in default and her appeal is DISMISSED.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to **file a petition for judicial review in District Court** within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

Una decisión de la Junta de Apelaciones de Empleo es una acción final de la agencia. Si una de las partes no está de acuerdo con la decisión de la Junta de Apelación de Empleo, puede presentar una petición de revisión judicial en el tribunal de distrito.

2.
