Section 96.4-3 - Able and Available

STATEMENT OF THE CASE:

The claimant filed a timely appeal from the October 27, 2005, reference 01, decision that found the claimant not able to and available for work thus denied unemployment insurance benefits. After due notice was issued, a hearing was held on November 17, 2005. The claimant did participate. The employer did not participate.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant has a work restriction of no lifting over ten pounds due to a non-work-related injury. The employer was able to accommodate her work restrictions up until August 2, 2005. The claimant believes she can perform work such as office or computer work, including customer

service or clerking in a doctor's office. The claimant believes she is able to work as an assistant manager, a food service manager and some chef and baker's positions. The claimant was able to work for her employer with a work restriction of ten pounds for at least some period of time.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes that the claimant is able to work and available for work

Iowa Code section 96.4-3 provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph 1, or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

871 IAC 24.22(1)a provides:

Benefits eligibility conditions. For an individual to be eligible to receive benefits the department must find that the individual is able to work, available for work, and earnestly and actively seeking work. The individual bears the burden of establishing that the individual is able to work, available for work, and earnestly and actively seeking work.

(1) Able to work. An individual must be physically and mentally able to work in some gainful employment, not necessarily in the individual's customary occupation, but which is engaged in by others as a means of livelihood.

a. Illness, injury or pregnancy. Each case is decided upon an individual basis, recognizing that various work opportunities present different physical requirements. A statement from a medical practitioner is considered prima facie evidence of the physical ability of the individual to perform the work required. A pregnant individual must meet the same criteria for determining ableness as do all other individuals.

871 IAC 24.23(35) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(35) Where the claimant is not able to work and is under the care of a physician and has not been released as being able to work.

Inasmuch as the injury was not work-related and the treating physician has not released the claimant to return to work, the claimant has not established ability to work for her employer

Care Initiatives. However, the claimant has established that she may be able to work at other types of work. The claimant has established that she can perform some jobs in the labor market. The claimant is able to and available for work effective August 2, 2005.

DECISION:

The representative's decision dated October 27, 2005, reference 01, is reversed. The claimant is able to work and available for work effective August 2, 2005. Benefits are allowed, provided the claimant is otherwise eligible.
