**STATEMENT OF THE CASE:**

The claimant, Warren Hardy, filed an appeal from an unemployment insurance decision dated March 24, 2017, reference 02. Before a hearing was scheduled, the claimant/appellant submitted a written withdrawal of this appeal. The appellant specifically asked to cancel this appeal.

**ISSUE:**

Should the appeal withdrawal be approved?

**FINDINGS OF FACT:**

An unemployment insurance decision was issued on March 24, 2017, reference 02, denying benefits as of 03/19/17 because the claimant failed to report for a reemployment and eligibility assessment on March 21, 2017. The claimant filed an appeal on March 29, 2017. On April 7, 2017, the claimant requested to withdraw this appeal, in writing, via fax. The IWD Appeals Bureau received the written withdrawal on that date. In his written request to cancel this appeal, the claimant stated that he attended his REA appointment and that his “claim will be unlocked back to the week it was originally locked so there is no reason for the appeal.”

The department representative issued a subsequent unemployment insurance decision dated April 10, 2017, reference 03, stating that the claimant participated in the reemployment and eligibility assessment and is eligible to receive unemployment insurance benefits beginning 03/19/17.

**REASONING AND CONCLUSIONS OF LAW:**

An appellant may submit a written request to withdraw his or her appeal at any time prior to the issuance of a decision. Iowa Admin. Code r. 871-26.8(1).

Based on the documents in the appeal file and the applicable law, the request of the appealing party to withdraw the appeal should be approved.

**DECISION:**

The appealing party's request to withdraw the appeal of the unemployment insurance decision dated March 24, 2017, reference 02, is approved. The decision dated April 10, 2017, reference 03, remains in full force and effect.
