Section 96.3-7 - Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

The claimant appealed a representative's decision dated February 14, 2005, reference 02, that concluded the claimant was overpaid unemployment insurance benefits in the amount of \$1,383.00 as a result of a disqualification decision. A telephone hearing was scheduled and held on March 23, 2005, pursuant to due notice. The claimant did participate. His daughter, Adela Suljevic, participated as an interpreter.

FINDINGS OF FACT:

The administrative law judge, having considered all of the evidence in the record, finds that: The overpayment issue in this case was created by a disqualification decision that has now

been affirmed. The overpayment amount of \$1,383.00 includes benefits paid directly to Mr. Suljevic and benefits paid on his behalf to state and federal taxing authorities.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code Section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that the claimant has been overpaid unemployment insurance benefits in the amount of \$1,383.00 pursuant to Iowa Code Section 96.3-7 as the disqualification decision that created the overpayment decision has now been affirmed.

DECISION:

The decision of the representative dated February 14, 2005, reference 02, is affirmed. The claimant has been overpaid unemployment insurance benefits in the amount of \$1,383.00.
