Section 96.5-1 - Voluntary Quit

STATEMENT OF THE CASE:

Katherine Winger (claimant) appealed an unemployment insurance decision dated October 22, 2004, reference 02, which held that she was not eligible for unemployment insurance benefits because she voluntarily quit her employment with Harris Hess (employer) without good cause attributable to the employer. After hearing notices were mailed to the parties' last-known addresses of record, a telephone hearing was held on November 16, 2004. The claimant participated in the hearing. The employer participated through Harris Hess.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds that: The claimant was employed as a full-time cook and housekeeper from April 1, 1999 through October 7, 2004. She had previously quit several times and the employer had allowed her to return to her employment. On October 7, 2004, the employer became upset with the claimant and another employee about how they were treating Marjorie Hess, an 81 year-old woman for whom they provided care. The employer "really blew up" even though he did not usually lose control. The employer told the claimant and her co-worker that they could either "fucking adapt [to Marjorie] or get the fuck out." The claimant gathered her things and left. The claimant's co-worker called the employer on the following day to inquire as to whether they still had their jobs and were told they were considered to have voluntarily quit.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the reasons for the claimant's separation from employment qualify her to receive unemployment insurance benefits. The claimant is not qualified to receive unemployment insurance benefits if she voluntarily quit without good cause attributable to the employer or if the employer discharged her for work-connected misconduct. Iowa Code sections 96.5-1 and 96.5-2-a.

A voluntary leaving of employment requires an intention to terminate the employment relationship accompanied by an overt act of carrying out that intention. <u>Local Lodge #1426 v. Wilson Trailer</u>, 289 N.W.2d 608, 612 (Iowa 1980). The claimant demonstrated her intent to quit and acted to carry it out when she left her employer after he told her to either adapt or get out. The employer never told the claimant she was fired.

The claimant has the burden to prove that the voluntary quit was for a good reason that would not disqualify her. Iowa Code section 96.6-2. She quit her employment after being reprimanded by her employer. The employer was upset with the claimant and her co-worker because he felt they were being abusive to Marjorie Hess, who was elderly and unable to provide care for herself. The employer told both individuals they either needed to adapt or get out since the 81 year-old woman was not going to change. The law presumes it is a quit without good cause attributable to the employer when an employee leaves after being reprimanded. 871 IAC 24.25(28). The claimant has failed to establish good cause for leaving her employment. Benefits are denied.

DECISION:

The unemployment insurance decision dated October 22, 2004, reference 02, is affirmed. The claimant voluntarily left work without good cause attributable to the employer. Benefits are withheld until she has worked in and has been paid wages for insured work equal to ten times her weekly benefit amount, provided she is otherwise eligible.
