## STATEMENT OF THE CASE:

The employer filed an appeal from the March 7, 2023, (reference 01) unemployment insurance decision that allowed benefits based upon a determination that claimant was on a short-term layoff. The parties were properly notified of the hearing. A telephone hearing was held on March 28, 2023. Claimant did not participate. Employer participated through senior payroll administrator Gail Dunahoo. Employer's Exhibit 1 was received. The administrative law judge took official notice of the administrative file.

## **ISSUES:**

Is the claimant totally, partially, or temporarily unemployed? Was the claimant able to and available for work effective February 19, 2023? Is the employer's account subject to charge?

#### FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant was employed full time as an apprentice laborer from February 6, 2023, through February 24, 2023, when he separated from employment.

Claimant filed his initial claim for benefits effective December 4, 2022. Claimant's weekly benefit amount is \$539.00. He filed an additional claim effective February 19, 2023. Claimant worked his regular full-time hours during the week ending February 25, 2023. Claimant reported earned wages in the amount of \$817.00 for the week ending February 25, 2023.

On February 24, 2023, employer permanently ended claimant's employment. The issue of whether claimant's separation qualifies him for benefits has not yet been investigated or adjudicated by the Benefits Bureau.

#### **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes the claimant was not partially, totally, or temporarily unemployed. Benefits are denied for the one-week period ending February 25, 2023.

Iowa Code § 96.1A(37) provides:

"Total and partial unemployment".

- a. An individual shall be deemed "totally unemployed" in any week with respect to which no wages are payable to the individual and during which the individual performs no services.
- b. An individual shall be deemed partially unemployed in any week in which either of the following apply:
- (1) While employed at the individual's then regular job, the individual works less than the regular full-time week and in which the individual earns less than the individual's weekly benefit amount plus fifteen dollars.
- (2) The individual, having been separated from the individual's regular job, earns at odd jobs less than the individual's weekly benefit amount plus fifteen dollars.
- c. An individual shall be deemed temporarily unemployed if for a period, verified by the department, not to exceed four consecutive weeks, the individual is unemployed due to a plant shutdown, vacation, inventory, lack of work or emergency from the individual's regular job or trade in which the individual worked full-time and will again work full-time, if the individual's employment, although temporarily suspended, has not been terminated.

Iowa Code section 96.7(2)a(2)(a), (b), and (c) provides:

- 2. Contribution rates based on benefit experience.
- a. (2) The amount of regular benefits plus fifty percent of the amount of extended benefits paid to an eligible individual shall be charged against the account of the employers in the base period in the inverse chronological order in which the employment of the individual occurred.
- (a) However, if the individual to whom the benefits are paid is in the employ of a base period employer at the time the individual is receiving the benefits, and the individual is receiving the same employment from the employer that the individual received during the individual's base period, benefits paid to the individual shall not be charged against the account of the employer. This provision applies to both contributory and reimbursable employers, notwithstanding subparagraph (3) and section 96.8, subsection 5.
- (b) An employer's account shall not be charged with benefits paid to an individual who left the work of the employer voluntarily without good cause attributable to the employer or to an individual who was discharged for misconduct in connection with the individual's employment, or to an individual

who failed without good cause, either to apply for available, suitable work or to accept suitable work with that employer, but shall be charged to the unemployment compensation fund. This paragraph applies to both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

(c) The amount of benefits paid to an individual, which is solely due to wage credits considered to be in an individual's base period due to the exclusion and substitution of calendar quarters from the individual's base period under section 96.23, shall be charged against the account of the employer responsible for paying the workers' compensation benefits for temporary total disability or during a healing period under section 85.33, section 85.34, subsection 1, or section 85A.17, or responsible for paying indemnity insurance benefits.

## Iowa Code § 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Under Iowa Employment Security Law, an individual must be unemployed to be eligible for benefits. Iowa Code § 96.19(38). Total and temporary unemployment occur when an individual has received no wages and performed no services during any given week. *Id.* An individual who is totally unemployed has been permanently separated from an employer, whereas an individual who is temporarily unemployed has not been permanently separated from employment. Here, claimant performed services for the employer and received wages during the week ending February 25, 2023. Employer paid the claimant wages during the period in which he was filing for unemployment benefits while he was still employed by employer. He was therefore not totally or temporarily unemployed.

The next question is whether he is partially unemployed. In order to be partially unemployed, an individual must be laid off from full-time employment or working less than their regular full-time work week and earn less than their weekly benefit amount plus fifteen dollars; for claimant, that amount is \$554.00. Here, claimant worked his regular full-time work week and earned more than his weekly benefit amount plus fifteen dollars for the one week ending February 25, 2023. Therefore, claimant is also not partially unemployed. As claimant is not unemployed as defined by lowa law, benefits are denied.

The issue of whether the claimant's separation qualifies claimant for benefits effective February 26, 2023, shall be remanded to the Benefits Bureau for a fact-finding interview and unemployment insurance decision.

## **DECISION:**

The March 7, 2023, (reference 01) unemployment insurance decision is modified in favor of the employer/appellant. Claimant is not unemployed under lowa law. Benefits are denied for the one-week period ending February 25, 2023.

## **REMAND:**

The issue of whether the claimant's separation qualifies claimant for benefits is remanded to the Benefits Bureau for a fact-finding interview and unemployment insurance decision

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

#### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final.
