Iowa Code § 96.6(1) – Filing Claims Iowa Admin. Code r. 871-24.2(1)a & h(1) & (2) – Backdating

STATEMENT OF THE CASE:

Claimant filed a timely appeal from the January 31, 2017, (reference 01) unemployment insurance decision that denied the request to backdate the additional claim for benefits prior to January 15, 2017. After due notice was issued, a hearing was scheduled to be held by telephone conference call on February 24, 2017. Claimant participated personally and through witness Diana Duncan.

ISSUE:

May the claim be backdated prior to January 15, 2017?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant filed a claim for benefits with an effective date of August 28, 2016, and an additional claim date effective January 15, 2017, and desires to backdate the additional claim to January 8, 2017. Claimant delayed filing the claim because he did not realize he was required to reopen his claim before filing a weekly claim. Claimant was laid off during the one week ending January 14, 2017. Claimant did not earn any wages that week and was available for work. Claimant tried to file his weekly continued claim that weekend, but was unable to do so as he had not reopened his claim. As soon as the agency offices reopened, on January 17, 2017, claimant went to his local office for help. Claimant then learned he was required to reopen his claim.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the claimant's request to backdate the claim is granted.

Iowa Code § 96.6(1) provides:

1. Filing. Claims for benefits shall be made in accordance with such regulations as the department may prescribe.

Iowa Admin. Code r. 871-24.2(1)h(1) and (2) provide:

Procedures for workers desiring to file a claim for benefits for unemployment insurance.

(1) § 96.6 of the employment security law of Iowa states that claims for benefits shall be made in accordance with such rules as the department prescribes. The department of workforce development accordingly prescribes:

h. Effective starting date for the benefit year.

(1) Filing for benefits shall be effective as of Sunday of the current calendar week in which, subsequent to the individual's separation from work, an individual reports in person at a workforce development center and registers for work in accordance with paragraph "a" of this rule.

(2) The claim may be backdated prior to the first day of the calendar week in which the claimant does report and file a claim for the following reasons:

Backdated prior to the week in which the individual reported if the individual presents to the department sufficient grounds to justify or excuse the delay;

There is scheduled filing in the following week because of a mass layoff;

The failure of the department to recognize the expiration of the claimant's previous benefit year;

The individual is given incorrect advice by a workforce development employee;

The claimant filed an interstate claim against another state which has been determined as ineligible;

Failure on the part of the employer to comply with the provisions of the law or of these rules;

Coercion or intimidation exercised by the employer to prevent the prompt filing of such claim;

Failure of the department to discharge its responsibilities promptly in connection with such claim, the department shall extend the period during which such claim may be filed to a date which shall be not less than one week after the individual has received appropriate notice of potential rights to benefits, provided, that no such claim may be filed after the 13 weeks subsequent to the end of the benefit year during which the week of unemployment occurred. In the event continuous jurisdiction is exercised under the provisions of the law, the department may, in its discretion, extend the period during which claims, with respect to week of unemployment affected by such redetermination, may be filed.

The IWD Unemployment Insurance Benefits Handbook indicates a claim effective date is the Sunday of the week in which the application was filed. There is no instruction that a new, additional or reopened claim must be filed before Saturday of the week of separation or unemployment. Since claimant attempted to file his weekly continued claim during the weekend, but was locked out of the online claim system, the delay in filing in person at the local office on Tuesday, January 17, 2017, is considered a good cause reason for having failed to file a claim during the first week of unemployment. Backdating is allowed.

DECISION:

The January 31, 2017, (reference 01) unemployment insurance decision is reversed. The claimant's request to backdate the claim to January 8, 2017, is granted, as are retroactive benefits for the same time period. Claimant did not earn any wages during the one week ending January 14, 2017.
