## STATEMENT OF THE CASE

Claimant/Appellant Karen Hendrickson appealed a decision issued by Respondent Iowa Workforce Development ("IWD") dated July 30, 2012, reference 04, finding Hendrickson failed to attend a reemployment and eligibility assessment on July 26, 2012, and denying benefits as of July 22, 2012. Hendrickson's appeal is on the decision, which was sent to 8602 Westown Parkway Apt 308 in West Des Moines.

#### 12IWDUI395

IWD transmitted the administrative file to the Department of Inspections and Appeals on September 11, 2012 to schedule a contested case hearing.

A contested case hearing was scheduled for October 29, 2012. On October 18, 2012, Hendrickson's copy of the Notice of Telephone Hearing was returned as "not deliverable as addressed, unable to forward." My office contacted IWD for an updated address for Hendrickson. IWD was unable to find an updated address for Hendrickson.

On October 29, 2012, Lori Arandus appeared for the hearing. She did not have an updated address for Hendrickson. Hendrickson has not received notice of the hearing. This is Hendrickson's appeal. She has not provided an updated address to IWD or this office. Because she has not received proper notice, the appeal is dismissed without prejudice.
