Section 96.5(1) – Quit  
Section 96.3(7) – Overpayment

STATEMENT OF THE CASE:

The employer, Ruan Transport, filed an appeal from a decision dated December 29, 2005, reference 01. The decision allowed benefits to the claimant, Roger Hogstad. After due notice was issued, a hearing was held by telephone conference call on January 23, 2006. The claimant did not provide a telephone number where he could be contacted and did not participate. The employer participated by Terminal Manager Gary Gebers.

#### FINDINGS OF FACT:

Having heard the testimony of the witnesses and having examined all of the evidence in the record, the administrative law judge finds: Roger Hogstad was employed by Ruan Transport from October 31, 1988 until August 31, 2005. He was a full-time over-the-road truck driver.

The claimant had been on vacation from August 21 through August 27, and was to return to work on August 28, 2005. He called on that day and told terminal Manager Gary Gebers he was having car trouble and could not come in that day. The load was rescheduled for the next day, but Mr. Hogstad also called in absent that day for the same reason. The same thing occurred on August 30, 2005, at which time Mr. Gebers said he could not postpone the load much longer. On August 31, 2005, the claimant called and said "it was not working out" and quit.

Roger Hogstad has received unemployment benefits since filing an additional claim with an effective date of November 27, 2005.

#### REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant is disqualified. The judge concludes he is.

Iowa Code section 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

871 IAC 24.25(1) provides:

Voluntary quit without good cause. In general, a voluntary quit means discontinuing the employment because the employee no longer desires to remain in the relationship of an employee with the employer from whom the employee has separated. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to Iowa Code section 96.5. However, the claimant has the initial burden to produce evidence that the claimant is not disqualified for benefits in cases involving Iowa Code section 96.5, subsection (1), paragraphs "a" through "i," and subsection 10. The following reasons for a voluntary quit shall be presumed to be without good cause attributable to the employer:

(1) The claimant's lack of transportation to the work site unless the employer had agreed to furnish transportation.

The claimant apparently quit because he did not have transportation to the terminal from which he was dispatched. Under the provisions of the above Administrative Code section, this is a voluntary quit without good cause attributable to the employer. The claimant is disqualified.

Iowa Code section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in

good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The claimant has received unemployment benefits to which he is not entitled. These must be recovered in accordance with the provisions of Iowa law.

DECISION:

The representative's decision of December 29, 2005, reference 01, is reversed. Roger Hogstad is disqualified and benefits are withheld until he has earned ten times his weekly benefit amount, provided he is otherwise eligible. He is overpaid in the amount of \$572.00.
