STATEMENT OF THE CASE

Claimant/Appellant Pamela Swyter appealed a decision issued by Respondent Iowa Workforce Development (“IWD”) dated August 22, 2013, Reference 03, finding Ms. Swyter was not eligible to receive unemployment insurance benefits effective August 18, 2013, because she was mailed a notice to report for a reemployment and eligibility assessment on August 21, 2013, and she failed to report to the class.

IWD transmitted the administrative file to the Department of Inspections and Appeals and the appeal was scheduled for a September 25, 2013 contested case telephone hearing. Prior to the hearing, Claimant/Appellant Swyter called me and stated that she wished to withdraw her appeal. I advised her that I needed something from her in writing stating she wished to withdraw her appeal.

I convened the telephone hearing at the scheduled date and time, 1 p.m. on September 25, 2013. Appellant Swyter did not appear for the telephone hearing. The Department was represented by Workforce Advisor Srdjan Golub, who presented testimony on the Department's behalf. The Department had also submitted an Appeal Summary dated September 3, 2013 with attached Exhibits A through C.

After the hearing, but before I wrote a decision based on the information presented at the hearing, I received a signed facsimile from Appellant Pam Swyter stating: "The issue I was appealing has been resolved. So I no longer need the appeal." Ms. Swyter's withdrawal request is incorporated into the record of this administrative appeal.

DECISION

This appeal is dismissed based on Appellant's Pamela Swyter's written withdrawal request.
