Section 96.5-1 – Voluntary Quit

STATEMENT OF THE CASE:

Employer filed an appeal from a decision of a representative dated January 22, 2004, reference 01, which held claimant eligible for unemployment insurance benefits. After due notice, a telephone conference hearing was scheduled for and held on February 24, 2004. Claimant participated. Employer participated by Kirk Schaptaugh, Owner, and Darin Shadle, Owner Assistant. Claimant failed to respond to the hearing notice and did not participate.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on October 31, 2003. The business was sold and new owners took over the business. Claimant remained in her position. There was no loss of work for which to demonstrate an actual separation of employment.

REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether claimant quit for good cause attributable to employer. The administrative law judge holds that the evidence has established that claimant did not separate from employment but changed work due to a sale of the business. No disqualification is imposed, as no separation occurred.

Iowa Code Section 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

DECISION:

The decision of the representative dated January 22, 2004, reference 01, is affirmed. Unemployment insurance benefits are allowed, provided claimant is otherwise eligible.
