STATEMENT OF THE CASE:

On April 4, 2022, Kali Brudos, claimant/appellant, appealed the decision dated April 7, 2022 (reference 03) that concluded the claimant was overpaid Federal Pandemic Unemployment Compensation (FPUC) in the amount of \$1,200.00 for the 2-week period ending July 25, 2020.

A telephone hearing was held on June 2, 2022, pursuant to due notice. The hearing was held together with Appeal 22A-UI-09457-ED-T. Claimant, Kali Brudos, participated personally. The administrative law judge took official notice of the administrative record.

ISSUE:

Was the claimant overpaid Federal Pandemic Unemployment Compensation (FPUC)?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant initially opened a claim for unemployment insurance benefits effective May 17, 2020. Claimant made a weekly continued claim for the week ending July 25, 2020. Iowa Workforce Development (IWD) issued claimant a payment of FPUC benefits in the gross amount of \$1,200.00 for the 2 - week period ending July 25, 2020. On March 2, 2021, Iowa Workforce Development (IWD) issued a decision denying claimant's eligibility for benefits. That decision has been affirmed. See 22A-UI-s019454-ED-T.

REASONING AND CONCLUSIONS OF LAW:

For the reasons set forth below, the administrative law judge concludes the claimant has been overpaid FPUC benefits.

PL116-136, Sec. 2104 provides, in pertinent part:

(b) Provisions of Agreement

(1) Federal pandemic unemployment compensation.--Any agreement under this section shall provide that the State agency of the State will make payments of

regular compensation to individuals in amounts and to the extent that they would be determined if the State law of the State were applied, with respect to any week for which the individual is (disregarding this section) otherwise entitled under the State law to receive regular compensation, as if such State law had been modified in a manner such that the amount of regular compensation (including dependents' allowances) payable for any week shall be equal to

(A) the amount determined under the State law (before the application of this paragraph), plus

(B) an additional amount of \$600 (in this section referred to as "Federal Pandemic Unemployment Compensation").

. . . .


(f) Fraud and Overpayments

(2) Repayment.--In the case of individuals who have received amounts of Federal Pandemic Unemployment Compensation to which they were not entitled, the State shall require such individuals to repay the amounts of such Federal Pandemic Unemployment Compensation to the State agency...

Claimant has received FPUC benefits to which she was not entitled. Therefore, the administrative law judge concludes that claimant has been overpaid FPUC benefits in the amount of \$1,200.00 for the 2-week period ending July 25, 2020. Those benefits are subject to recovery in accordance with Iowa law, unless the overpayment balance is waived. Information on how to apply for a waiver is included below.

DECISION:

The April 7, 2022 (reference 3) unemployment insurance decision is affirmed. Claimant has been overpaid FPUC benefits in the amount of \$1,200.00.

NOTE TO CLAIMANT:

This decision determines claimant is overpaid FPUC benefits, and the administrative law judge lacks authority to waive the overpayment. If claimant disagrees with this decision claimant may file an appeal to the Employment Appeal Board by following the instructions on the first page of this decision.

Claimant may also apply for a waiver of the overpayment balance. The written request must include the following information:

- 1. Claimant name & address.
- 2. Decision number/date of decision.
- 3. Dollar amount of overpayment you want the agency to waive.
- 4. Relevant facts that you feel justify a waiver.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

1) The name, address, and social security number of the claimant.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
