STATEMENT OF THE CASE:

Employer filed an appeal from a decision of a statement of charges dated August 9, 2023, reference 00, which assessed charges for the second quarter of 2023. After due notice, a telephone conference hearing was scheduled for and held on August 29, 2023. Claimant participated personally. Employer participated by Morgan Wentland.

ISSUES:

Whether the statement of charges is correct.

Whether the statement of charges is timely appealed.

Whether the employer's protest is timely.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: A statement of charges was mailed to the employer on August 9, 2023. The employer appealed the statement of charges on the basis that the protest to the Notice of Claim was filled out and returned by a person who does not normally fill out these documents for employer. Employer's vice president for human resources was out on maternity leave at or around the time that claimant filed for unemployment in March of 2023, and a fill-in was aiding in the administration of paperwork. Although the fill-in did nothing intentionally improper, she did state on the Notice of Claim that employer was not protesting the claim. This lack of protestation is what led to claimant's receipt of unemployment benefits in the amount of \$1,297.50 for the second quarter of 2023 that he otherwise would not have been eligible to receive as he chose to voluntarily quit his position.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.6(2) provides, in pertinent part:

The representative shall promptly examine the claim and any protest, take the initiative to ascertain relevant information concerning the claim, and, on the basis of the facts found by the representative, shall determine whether or not the claim is valid, the week with respect to which benefits shall commence, the weekly benefit amount payable and its maximum duration, and whether any disqualification shall be imposed. . . . Unless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision.

Iowa Code section 96.7 provides, in relevant part:

Employer contributions and reimbursements.

- 7. Financing benefits paid to employees of governmental entities.
- c. For purposes of this subsection, "governmental reimbursable employer" means an employer which makes payments to the department for the unemployment compensation fund in an amount equivalent to the regular and extended benefits paid, which are based on wages paid for services in the employ of the employer. Benefits paid to an eligible individual shall be charged against the base period employers in the inverse chronological order in which the employment of the individual occurred. However, the amount of benefits charged against an employer for a calendar quarter of the base period shall not exceed the amount of the individual's wage credits based upon employment with that employer during that quarter. At the end of each calendar quarter, the department shall bill each governmental reimbursable employer for benefits paid during that quarter. Payments by a governmental reimbursable employer shall be made in accordance with subsection 8, paragraph "b", subparagraphs (2) through (5).
- 8. Financing benefits paid to employees of nonprofit organizations.

. . .

b. Reimbursements for benefits paid in lieu of contributions shall be made in accordance with the following:

. .

- (4) The amount due specified in a bill from the department is conclusive unless, not later than fifteen days following the date the bill was mailed or otherwise delivered to the last known address of the nonprofit organization, the nonprofit organization files an application for redetermination with the department setting forth the grounds for the application. The department shall promptly review the amount due specified in the bill and shall issue a redetermination. The redetermination is conclusive on the nonprofit organization unless, not later than thirty days after the redetermination was mailed or otherwise delivered to the last known address of the nonprofit organization, the nonprofit organization files an appeal to the district court pursuant to subsection 5.
- (5) The provisions for collection of contributions under section 96.14 are applicable to reimbursements for benefits paid in lieu of contributions.

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

- 2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:
- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.
- 3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the guarterly statement of benefit charges.
- 4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

lowa Code section 96.7(2)a(6), which applies to contributory employers, provides guidance in the situation here, which deals with a reimbursable employer. It states that a contributory employer who did not receive notice of the claim may appeal to the department for a hearing to determine the eligibility of an individual to receive benefits following receipt of a statement of charges. While lowa Code sections 96.7(7) and (8) which address reimbursable employers do not specifically state the reimbursable employers have appeal rights following the notice of reimbursable charges if they did not receive prior notice of the claim, lowa Admin Code r. 871-26.4(4) allows for such an appeal.

Employer did receive notice of the claim. Employer's appeal of the notice of reimbursable charges within 15 days is timely.

It is held that the statement of charges is correct because employer's agent filled out and returned the notice stating that employer was not protesting the claim. Claimant only received unemployment benefits because employer's agent did not protest the claim. The administrative law judge will not go back months later and find that a duly appointed agent for the employer made an error that was not recognized, and therefore potentially find claimant to be overpaid benefits many months after receipt of said benefits simply because of employer error.

DECISION:

The statement of charges dated August 9, 2023, reference 00, is affirmed. The statement of charges is correct.

- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.
