DECISION

FINDINGS OF FACT:

The notice of hearing in this matter was mailed February 12, 2021. The notice set a hearing for March 9, 2021. The Claimant did not appear for or participate in the hearing. The reason the Claimant did not appear is because the Claimant did not provide a telephone number at which the Claimant could be reached. Thus, the Claimant did not receive the call. When the Claimant realized no call was forthcoming, the Claimant contacted the administrative law judge approximately 8 minutes after the scheduled start of the hearing.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 10A.601(4) (2021) provides:

4. Appeal board review. The appeal board may on its own motion affirm, modify, or set aside any decision of a administrative law judge on the basis of the evidence previously submitted in such case, or direct the taking of additional evidence, or may permit any of the parties to such decision to initiate further appeals before it. The appeal board shall permit such further appeal by any of the parties interested in a decision of an administrative law judge and by the representative whose decision has been overruled or modified by the administrative law judge. The appeal board shall review the case pursuant to rules adopted by the appeal board. The appeal board shall promptly notify the interested parties of its findings and decision.

Here the Claimant did not participate in the hearing because the Claimant had not provided a telephone number for the administrative law judge to call. When the Claimant did not receive a call, the Claimant contacted the administrative law judge within a reasonable timeframe after the scheduled hearing time, which established the Claimant's intention to follow through with the appeals process. For this reason, the matter will be remanded for another hearing before an administrative law judge so that the Claimant may participate in the hearing.

We caution the Claimant that,	, barring exceptional	circumstances,	we will not again	excuse a failure	to call in or
register on-line a number whe	re the Claimant could	d be reached.			

DECISION:

The decision of the administrative law judge dated March 11, 2021 is not vacated and remains in force unless and until the Department makes a differing determination pursuant to this remand. This matter is remanded to an administrative law judge in the Workforce Development Center, Appeals Section. The administrative law judge shall conduct a hearing following due notice. After the hearing, the administrative law judge shall issue a decision which provides the parties appeal rights.
