Section 96.5-1 - Voluntary Quit

STATEMENT OF THE CASE:

Claimant filed an appeal from a decision of a representative dated May 17, 2005, reference 01, which held claimant ineligible for unemployment insurance benefits. After due notice, a telephone conference hearing was scheduled for and held on June 16, 2005. Claimant failed to participate, as she was not available at the telephone number left with the Appeals Bureau. Employer participated by Brad Hansen, Used Car Manager.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on December 16, 2004. Claimant quit due

to alleged harassment by a coworker. Claimant did not report the alleged incidents to the employer.

REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether claimant quit for good cause attributable to employer. The administrative law judge holds that the evidence has failed to establish that claimant voluntarily quit for good cause attributable to employer when claimant terminated the employment relationship because of alleged harassment. Claimant failed to participate in the hearing. The only information concerning the reason for the quit was claimant's appeal letter, which was read into the record. This is hearsay. Employer's testimony and evidence was under oath by in person testimony. The sworn statements are more credible than hearsay. As such, employer's version is found correct. Claimant failed to report any incident of harassment to the employer. Since employer did not have a chance to investigate and resolve the conflict this is a separation without cause attributable to employer. Claimant left for reasons that do not amount to good cause attributable to employer. Benefits withheld.

Iowa Code section 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

871 IAC 24.25(6) provides:

Voluntary quit without good cause. In general, a voluntary quit means discontinuing the employment because the employee no longer desires to remain in the relationship of an employee with the employer from whom the employee has separated. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to Iowa Code section 96.5. However, the claimant has the initial burden to produce evidence that the claimant is not disqualified for benefits in cases involving Iowa Code section 96.5, subsection (1), paragraphs "a" through "i," and subsection 10. The following reasons for a voluntary quit shall be presumed to be without good cause attributable to the employer:

(6) The claimant left as a result of an inability to work with other employees.

DECISION:

The decision of the representative dated May 17, 2005, reference 01, is affirmed. Unemployment insurance benefits shall be withheld until claimant has worked in and been paid wages for insured work equal to ten times claimant's weekly benefit amount, provided claimant is otherwise eligible.
