Iowa Code § 96.6(2) – Timely Appeal

STATEMENT OF THE CASE:

Osmundson Mfg Co, the employer/appellant, filed an appeal from the Iowa Workforce Development January 26, 2023 (reference 03) unemployment insurance (UI) decision. The decision allowed Mr. Kilts REGUALR (state) UI benefits because IWD concluded that the employer did not file its protest of Mr. Kilts' claim on time. The Iowa Department of Inspections and Appeals UI Appeals Bureau mailed a notice of hearing to the employer and Mr. Kilts. A telephone hearing was held on February 21, 2023. The employer participated through Lynne Blake, human resources manager. Mr. Kilts did not participate in the hearing. The administrative law judge took official notice of the administrative record.

ISSUES:

Did the employer file its appeal on time?
Did the employer file its protest of Mr. Kilts' claim on time?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: IWD mailed the January 26, 2023, (reference 03) UI decision to the employer at the correct address on January 26, 2023. The UI decision states that it becomes final unless an appeal is postmarked or received by the IWD Appeals Section by February 5, 2023. If the appeal deadline falls on a Saturday, Sunday, or legal holiday, the appeal period is extended to the next working day. February 5, 2023 was a Sunday. So, the appeal deadline was extended to Monday, February 6, 2023.

The employer received the decision in the mail on Tuesday, January 31, 2023. Ms. Blake is the employer's only human resources person, and she was out of the office the week of January 30 – February 3. Ms. Blake returned to work on Monday, February 6. Ms. Blake was busy completing other tasks that day. Ms. Blake filed the employer's appeal online on February 7, 2023. The appeal was received on February 7, 2023.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer's appeal of the January 26, 2023 (reference 03) UI decision was not filed on time.

Iowa Code § 96.6(2) provides, in pertinent part: “[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision.”

Iowa Admin. Code r. 871-24.35(1) provides:

2. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:

(2) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.

(b) If transmitted via the State Identification Data Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.

(c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed.¹ Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid.²

The employer received the January 26, 2023 (reference 03) UI decision before the appeal deadline and, therefore, could have filed an appeal by the deadline. The notice provision of the decision was valid. The employer's delay in filing its appeal was not due to an error or misinformation from IWD or due to delay or other action of the United States Postal Service. No

other good cause reason has been established for the delay in filing the appeal. The employer's appeal of the January 26, 2023 (reference 03) UI decision was not filed on time and the administrative law judge lacks jurisdiction (authority) to decide the other issue in this matter.

DECISION:

The employer's appeal of the January 26, 2023 (reference 03) UI decision was not filed on time. The January 26, 2023 (reference 03) UI decision allowing Mr. Kilts REGULAR (state) UI benefits is AFFIRMED.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to **file a petition for judicial review in District Court** within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
