**STATEMENT OF THE CASE:**

Claimant filed an appeal from a decision of a representative dated June 29, 2023, (reference 03) which held claimant ineligible for unemployment insurance benefits. After due notice, a hearing was scheduled for and held on July 28, 2023. Claimant participated. Employer did not participate.

**ISSUE:**

The issue in this matter is whether claimant quit for good cause attributable to employer.

**FINDINGS OF FACT:**

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on June 2, 2023. Claimant voluntarily quit on that date as she was bothered by the stressful environment of the kennel.

Claimant was hired on May 26, 2023 to be a full time manager in training. Claimant stated that she felt employer's business was unorganized. She moved a jar of peanut butter from a shelf containing chemicals.

A main reason for claimant's leaving was the amount of stress at work. A dog jumped a fence and claimant stated that she was yelled at when she went after the dog, leaving another dog within the fence. On another occasion she had to break up a dog fight.

During the week claimant worked for employer, they quickly moved her from working with small dogs to medium sized dogs.

Claimant stated that on June 2 she worked longer than anticipated. At the end of the day she told employer that she quit.

**REASONING AND CONCLUSIONS OF LAW:**

Iowa Code section 96.5(1) provides:

An individual shall be disqualified for benefits, regardless of the source of the individual's wage credits:


1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

The administrative law judge holds that the evidence has failed to establish that claimant voluntarily quit for good cause attributable to employer when claimant terminated the employment relationship because she was stressed by an environment with many dogs acting in ways that dogs might by fighting and trying to run off. Additionally, claimant was stressed about working late one day and seeing peanut butter in a cabinet with chemicals.

Ordinarily "good cause" is derived from the facts of each case keeping in mind the public policy stated in Iowa Code Section 96.2. *O'Brien v. EAB* 494 N.W.2d 660, 662 (Iowa 1993) (citing *Wiese v. IA Dept. of Job Serv.*, 389 N.W.2d 676, 680 (Iowa 1986)). "The term encompasses real circumstances, adequate excuses that will bear the test of reason, just grounds for the action, and always the test of good faith." *Wiese v. IA Dept. of Job Serv.*, 389 N.W.2d 676, 680 (Iowa 1986). "Common sense and prudence must be exercised in evaluating all of the circumstances that led to an employee's quit in order to attribute the cause for the termination." *Id.* Using common sense, dogs will often get excited and potentially run off from a kennel – given the opportunity. Dogs often take medications with peanut butter. Dogs sometimes get into fights with one another. Although claimant gives many reasons for her quit, all seem to be normal kennel actions. Claimant did state that she had dog experience. Claimant may certainly quit as she was not comfortable with the kennel environment, but such quit was not shown to be for good cause attributable to employer. Benefits are denied.

#### **DECISION:**

The decision of the representative dated June 29, 2023, (reference 03) is affirmed. Unemployment insurance benefits shall be withheld until claimant has worked in and been paid wages for insured work equal to ten times claimant's weekly benefit amount, provided claimant is otherwise eligible.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday. *There is no filing fee to file an appeal with the Employment Appeal Board.*

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may file a petition for judicial review in district court.

2. If you do not file an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at [www.iowacourts.gov/efile](http://www.iowacourts.gov/efile). *There may be a filing fee to file the petition in District Court.*

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
