Section 96.5-2-a – Discharge for Misconduct

STATEMENT OF THE CASE:

Home Depot U.S.A. (employer) appealed a representative's July 9, 2004 decision (reference 01) that concluded Adam Curry (claimant) was discharged and there was no evidence of willful or deliberate misconduct. After hearing notices were mailed to the parties' last-known addresses of record, a telephone hearing was held on August 10, 2004. The claimant did not provide a telephone number where he could be reached and, therefore, did not participate. The employer participated by Ron Stegall, Human Resources Manager.

# FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds that: The claimant was hired on February 6, 2003, as a full-time receiving associate. The claimant received a verbal warning on April 30, 2004, when he lost control of the forklift he was driving and broke an eight-foot special-order window. On May 6, 2004, the claimant received a written warning for crushing a \$259.00 grill while moving a shed out to the store floor with a forklift. The employer issued the claimant a written warning on August 26, 2004, when he turned a corner with his forklift and the tub and shower unit he was moving fell off. The claimant understood he could be terminated for further carelessness.

On November 12, 2003, the claimant dropped a bunk of drywall when moving it with a forklift. He broke six sheets and damaged the rest of the sheets in the bunk. The employer terminated the claimant on November 13, 2003 for repeated carelessness.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant was discharged for misconduct. For the following reasons the administrative law judge concludes he was.

Iowa Code Section 96.5-2-a provides:

An individual shall be disqualified for benefits:

2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:

a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

871 IAC 24.32(1)a provides:

Discharge for misconduct.

(1) Definition.

a. "Misconduct" is defined as a deliberate act or omission by a worker which constitutes a material breach of the duties and obligations arising out of such worker's contract of employment. Misconduct as the term is used in the disqualification provision as being limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. On the other hand mere inefficiency, unsatisfactory conduct, failure in good performance as the result of inability or incapacity, inadvertencies or ordinary negligence in isolated instances, or good faith errors in judgment or discretion are not to be deemed misconduct within the meaning of the statute. This definition has been accepted by the Iowa Supreme Court as accurately reflecting the intent of the legislature. <u>Huntoon v. Iowa Department of Job Service</u>, 275 N.W.2d 445, 448 (Iowa 1979).

The employer has the burden of proof in establishing disqualifying job misconduct. <u>Cosper v.</u> <u>Iowa Department of Job Service</u>, 321 N.W.2d 6 (Iowa 1982). Negligence does not constitute misconduct unless recurrent in nature; a single act is not disqualifying unless indicative of a deliberate disregard of the employer's interests. <u>Henry v. Iowa Department of Job Service</u>, 391 N.W.2d 731 (Iowa App. 1986). An employer has a right to expect employees to conduct themselves in a certain manner. The claimant disregarded the employer's right by being repeatedly careless in the performance of his job after having been warned. The claimant's disregard of the employer's interests is misconduct. As such, he is not eligible to receive unemployment insurance benefits.

## DECISION:

The representative's July 9, 2004 decision (reference 01) is reversed. The claimant is not eligible to receive unemployment insurance benefits because he was discharged from work for misconduct. Benefits are withheld until he has worked in and has been paid wages for insured work equal to ten times his weekly benefit amount, provided he is otherwise eligible.
