STATEMENT OF THE CASE:

On May 14, 2024, the employer, RJ Personnel Inc., filed an appeal from the statement of charges dated May 9, 2024, which listed benefit charge information for the first quarter of 2024. Pursuant to due notice, a telephone hearing was held on May 28, 2024. The claimant, Nick Lewis, did not participate. The employer participated through Account Manager Rachel Brockert. The Employer's Exhibit 1 was admitted into evidence. The administrative law judge took official notice of the claimant's unemployment insurance benefits records including the notice of claim.

ISSUES:

Was the employer's protest timely?
Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant separated from employment on May 3, 2023, and filed a claim for benefits effective November 26, 2023. Iowa Workforce Development (IWD) mailed a notice of claim to the employer's address of record on November 29, 2023. There is no copy of the employer's protest response in the administrative record. However, the employer submitted evidence showing that it received the notice of claim and emailed a response protesting the claim to Iowa Workforce Development (IWD) on December 5, 2023. IWD responded to the employer's email confirming receipt of the employer's protest on December 7, 2023. No fact-finding interview was scheduled or held regarding the claimant's employment with this employer. On May 9, 2024, a statement of charges was mailed to the employer for the first quarter of 2024. The employer filed its appeal of that statement of charges on May 14, 2024.

The issue of whether the claimant's separation qualifies him for benefits and whether the employer's account will be charged has not yet been investigated or adjudicated by the Benefits Bureau of IWD.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer timely filed its appeal to the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

Filing – determination – appeal.

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

Employer contribution and reimbursements.

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing.

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.


The employer filed a protest in a timely manner on December 5, 2023, and the department confirmed receipt of the employer's protest. Therefore, the protest shall be accepted as timely. The employer filed the appeal to the statement of charges within thirty days of the mailing of the statement of charges making the appeal timely. The issues of whether claimant's separation from this employer qualifies him for benefits and whether the employer's account will be charged are remanded to the Benefits Bureau of Iowa Workforce Development for an initial investigation and determination.

DECISION:

The conditions for appealing the statement of charges have been met. The May 9, 2024, statement of charges for the first quarter of 2024 is affirmed, pending the outcome of the remanded issue.

REMAND:

The issues of whether the claimant's separation from employment with the employer, RJ Personnel Inc., was disqualifying and whether the employer's account shall be charged are remanded to the Benefits Bureau of Iowa Workforce Development for an initial investigation and determination.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
