STATEMENT OF THE CASE:

The claimant Daryl L. Hinners appealed a representative's decision dated May 30, 2022 (reference 04), that concluded the claimant was overpaid regular state unemployment insurance, Federal Pandemic Unemployment Compensation (FPUC), and Lost Wages Assistance Program (LWAP) benefits as a result of a disqualification decision. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on August 4, 2022. Claimant participated personally. Joyce Hinners testified on claimant's behalf. The administrative law judge took official notice of the administrative record.

ISSUES:

Is the claimant overpaid unemployment insurance benefits?

Is the claimant overpaid FPUC benefits?

Is the claimant overpaid LWAP benefits?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: On July 15, 2021, lowa Workforce Development (IWD) issued a decision (reference 01) that denied claimant regular state unemployment insurance (UI) benefits. That decision has been affirmed. See 22A-UI-15928-ED-T, 21B-UI-15928. Claimant has received regular unemployment insurance benefits in the gross amount of \$4,966.00 for the twenty-six-week period ending January 23, 2021. Claimant has received FPUC benefits in the gross amount of \$9,600.00 for the sixteen-week period ending July 25, 2020, and \$600.00 for the two-week period ending January 23, 2021. Claimant has received LWAP benefits in the gross amount of \$1,800.00 for the six-week period ending September 5, 2020.

REASONING AND CONCLUSIONS OF LAW:

For the following reasons the administrative law judge concludes the claimant was overpaid regular state unemployment insurance, FPUC, and LWAP benefits for the period in question.

lowa Code § 96.3(7) provides, in pertinent part:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.
- b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

PL116-136, Sec. 2104 provides, in pertinent part:

- (b) Provisions of Agreement
- (1) Federal pandemic unemployment compensation.--Any agreement under this section shall provide that the State agency of the State will make payments of regular compensation to individuals in amounts and to the extent that they would be determined if the State law of the State were applied, with respect to any week for which the individual is (disregarding this section) otherwise entitled under the State law to receive regular compensation, as if such State law had been modified in a manner such that the amount of regular compensation (including dependents' allowances) payable for any week shall be equal to
- (A) the amount determined under the State law (before the application of this paragraph), plus
- (B) an additional amount of \$600 (in this section referred to as "Federal Pandemic Unemployment Compensation").

. . . .

- (f) Fraud and Overpayments
- (2) Repayment.--In the case of individuals who have received amounts of Federal Pandemic Unemployment Compensation to which they were not entitled, the State shall require such individuals to repay the amounts of such Federal Pandemic Unemployment Compensation to the State agency...

The decision that denied claimant regular unemployment insurance benefits remains in effect. Claimant is not eligible for UI benefits. Because claimant is not eligible for UI benefits, claimant is also not eligible for FPUC and LWAP benefits. Therefore, claimant has received UI, FPUC, and LWAP benefits to which he was not entitled. The administrative law judge concludes that

claimant has been overpaid UI, FPUC, and LWAP benefits in the amount outlined in the findings of fact above. Those benefits must be recovered in accordance with lowa law.

DECISION:

The decision of the representative dated May 30, 2022, (reference 04) is AFFIRMED. Claimant has been overpaid UI benefits in the amount of \$4,966.00, which must be repaid. Claimant has been overpaid FPUC benefits in the amount of \$10,200.00, which must be repaid. Claimant has been overpaid LWAP benefits in the amount of \$1,800.00, which must be repaid.

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
