# STATEMENT OF THE CASE:

The employer filed an appeal from the January 20, 2023, (reference 02) unemployment insurance decision that allowed benefits based upon the determination that claimant was on short-term layoff. The parties were properly notified of the hearing. A telephone hearing was held on February 14, 2023. The claimant, Suzanne R. Iehl, participated personally. The employer, Remedy Intelligent Staffing Inc., participated through Dawn Starr. The administrative law judge took official notice of the administrative record.

# **ISSUES:**

Is the claimant totally, partially or temporarily unemployed? Is the claimant able to and available for work? Is the claimant still employed at the same hours and wages? Is the employer's account subject to charge?

## **FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant first became employed with the employer on February 25, 2022. She remains employed as of the date of her unemployment appeal hearing.

Claimant is, and for some time has been, a system lead at General Mills. Because of her position, during periods of plant shutdown, she is someone who is expected to return and resume her job upon operations resuming.

Effective December 22, 2022, the General Mills plant in Cedar Rapids shut down. This lasted until January 2, 2023. Clamant returned to work, resuming her same job title, wages, and hours as before the plant shutdown.

Claimant filed a claim for unemployment benefits with an effective date of February 13, 2022, but did not file any weekly continuing claims at that time. She filed an additional claim for benefits with an effective date of December 18, 2022. She filed weekly continuing claims in the weeks ending December 24, 2022, and December 31, 2022. During the week ending December 24, 2022, she reported wages, but those did not exceed her weekly benefit amount—\$521.00—plus \$15, or \$536.00, so she received a partial benefit payment for that week.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes:

Iowa Code section 96.1A(37) provides:

"Total and partial unemployment".

- a. An individual shall be deemed "totally unemployed" in any week with respect to which no wages are payable to the individual and during which the individual performs no services.
- b. An individual shall be deemed partially unemployed in any week in which either of the following apply:
- (1) While employed at the individual's then regular job, the individual works less than the regular full-time week and in which the individual earns less than the individual's weekly benefit amount plus fifteen dollars.
- (2) The individual, having been separated from the individual's regular job, earns at odd jobs less than the individual's weekly benefit amount plus fifteen dollars.
- c. An individual shall be deemed temporarily unemployed if for a period, verified by the department, not to exceed four consecutive weeks, the individual is unemployed due to a plant shutdown, vacation, inventory, lack of work or emergency from the individual's regular job or trade in which the individual worked full-time and will again work full-time, if the individual's employment, although temporarily suspended, has not been terminated.

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.1A, subsection 37, paragraph "b", subparagraph (1), or temporarily unemployed as defined in section 96.1A, subsection 37, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871—24.23(26) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(26) Where a claimant is still employed in a part-time job at the same hours and wages as contemplated in the original contract for hire and is not working on a reduced workweek basis difference from the contract for hire, such claimant cannot be considered partially unemployed.

Iowa Code section 96.7(2)a(2) provides:

- 2. Contribution rates based on benefit experience.
- a. (2) The amount of regular benefits plus fifty percent of the amount of extended benefits paid to an eligible individual shall be charged against the account of the employers in the base period in the inverse chronological order in which the employment of the individual occurred.
- (a) However, if the individual to whom the benefits are paid is in the employ of a base period employer at the time the individual is receiving the benefits, and the individual is receiving the same employment from the employer that the individual received during the individual's base period, benefits paid to the individual shall not be charged against the account of the employer. This provision applies to both contributory and reimbursable employers, notwithstanding subparagraph (3) and section 96.8, subsection 5.
- (b) An employer's account shall not be charged with benefits paid to an individual who left the work of the employer voluntarily without good cause attributable to the employer or to an individual who was discharged for misconduct in connection with the individual's employment, or to an individual who failed without good cause, either to apply for available, suitable work or to accept suitable work with that employer, but shall be charged to the unemployment compensation fund. This paragraph applies to both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.
- (c) The amount of benefits paid to an individual, which is solely due to wage credits considered to be in an individual's base period due to the exclusion and substitution of calendar quarters from the individual's base period under section 96.23, shall be charged against the account of the employer responsible for paying the workers' compensation benefits for temporary total disability or during a healing period under section 85.33, section 85.34, subsection 1, or section 85A.17, or responsible for paying indemnity insurance benefits.

From December 18, 2022, through December 31, 2022, claimant meets the definition of a person who is temporarily unemployed. She was partially unemployed during the benefit week ending December 24, 2022, and was entitled to a partial benefit payment for that week. She was totally unemployed, because she earned no wages and worked no hours, during the week that ended December 31, 2022. Benefits are allowed provided claimant is otherwise eligible and subject to claimant reporting wages earned. Inasmuch as employer is not offering the same wages and hours as contemplated at hire, its account may be charged.

# **DECISION:**

The January 20, 2023, (reference 02) unemployment insurance decision is AFFIRMED. Claimant is temporarily unemployed. Benefits are allowed. The account of the employer, Remedy Intelligent Staffing Inc. (account # 298255-000), may be charged.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

#### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
