STATEMENT OF THE CASE:

Sergio H. Gil Escobar, the claimant/appellant,¹ appealed the Iowa Workforce Development (IWD) August 3, 2023 (reference 08) unemployment insurance (UI) decision. IWD denied Mr. Gil Escobar REGULAR (state) UI benefits because IWD concluded he voluntarily quit on July 7, 2023 for personal reasons. On September 28, 2023, the Iowa Department of Inspections, Appeals and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing to Mr. Gil Escobar and the employer for a telephone hearing scheduled for October 11, 2023.

The undersigned administrative law judge held a telephone hearing on October 11, 2023. Mr. Gil Escobar participated in the hearing personally through a CTS Language Link Spanish interpreter. Mary Hamilton, attorney, represented Mr. Gil Escobar. The employer participated in the hearing through Andee Long, human resources leader, Jason Smith, area manager, and Mary Kozlowski-Vought, Equifax appeal representative. The undersigned took official notice of the administrative record.

ISSUES:

Did Mr. Gil Escobar appeal on time?

Did Mr. Gil Escobar voluntarily quit without good cause attributable to the employer?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the undersigned finds: IWD mailed the August 3, 2023 (reference 08) UI decision to Mr. Gil Escobar at his correct address. The UI decision states that it becomes final unless an appeal is postmarked or received by the IWD Appeals Section by Sunday, August 13, 2023. If the appeal deadline falls on a Saturday, Sunday, or legal holiday, the appeal period is extended to the next working day. So, the appeal deadline was extended to Monday, August 14, 2023.

Mr. Gil Escobar received the decision in the mail on, or about Sunday, August 28. He called IWD about two days later and asked why he was denied benefits. Mr. Gil Escobar concluded that it was a lost cause, so he did not file an appeal at this time.

¹ Claimant is the person who applied for UI benefits. Appellant is the person or employer who appealed.

About a month later, Mr. Escobar decided that he wanted to appeal because he felt the decision was unfair. Mr. Escobar went to the IWD local office and asked for help appealing the decision. A Spanish speaking IWD representative helped Mr. Escobar appeal. Mr. Escobar appealed on September 26, 2023. The DIAL UI Appeals Bureau received the appeal the same day.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the undersigned concludes Mr. Gil Escobar did not appeal the August 3, 2023 (reference 08) UI decision on time.

lowa Code § 96.6(2) provides, in relevant part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

- 2. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:
- (2) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- (b) If transmitted via the State Identification Date Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- (c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed.²

Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid.³

Mr. Gil Escobar received the August 3, 2023 (reference 08) UI decision after the appeal deadline and, therefore, could not have appealed by the deadline. The notice provision of the decision was invalid. Even though he received the decision after the appeal deadline, Mr. Gil Escobar's delay in appealing was not due to an error or misinformation from IWD or due to delay or other action of the United States Postal Service. Mr. Gil Escobar has not established any other good cause reason for his delay in appealing. Mr. Gil Escobar did not appeal the August 3, 2023 (reference 08) UI decision on time and the undersigned lacks jurisdiction (authority) to decide the other issue in this matter.

DECISION:

Mr. Gil Escboar did not appeal the August 3, 2023 (reference 08) UI decision on time. The August 3, 2023 (reference 08) UI decision is AFFIRMED.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
