STATEMENT OF THE CASE

Claimant/Appellant Vivian Lowe appealed a decision issued by Respondent Iowa Workforce Development ("IWD") dated November 9, 2011, reference 02, finding she failed to attend reemployment services orientation on November 2, 2011, and denying benefits as of November 13, 2011.

IWD transmitted the administrative file to the Department of Inspections and Appeals on December 19, 2011 to schedule a contested case hearing. A contested case hearing was scheduled for January 11, 2011. On December 29, 2011, I received a decision dated November 15, 2011, reference 03, finding Lowe was eligible for unemployment insurance benefits effective November 13, 2011. The benefits have been released to Lowe that are the subject of this appeal. IWD requests the appeal be dismissed. Because no issues remain for resolution in this administrative appeal, the appeal is dismissed.

DECISION
