STATEMENT OF THE CASE:

On May 30, 2023, Sedona Staffing Inc (employer) filed an appeal from the statement of charges mailed on May 9, 2023, for the first quarter of 2023. A hearing was held at 11:00 a.m. June 23, 2023, pursuant to due notice. Brianna Soppe (claimant), did not participate. The employer did participate through Colleen McGuinty. No exhibits were offered or admitted.

ISSUES:

Was the employer's protest timely?
Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant filed a claim for benefits effective October 16, 2022. The notice of claim was mailed to the employer's address of record on December 29, 2022. The employer did receive that notice and filed its protest on December 29, 2022. An Iowa Workforce Development decision dated January 20, 2023 (reference 03) allowed benefits. The employer first became aware that it was being charged for benefits paid to claimant upon its receipt of the statement of charges mailed May 9, 2023 for the first quarter of 2023. The employer filed its appeal of that statement of charges on May 30, 2023.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes employer has not appropriately filed an appeal of the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. *An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits.* The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. [Emphasis added.]

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.


3. *Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.*

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

An employer may appeal a statement of charges when it has not received prior notice of a valid claim for benefits. Here, employer received notice of claimant's filing for unemployment insurance benefits through the initial notice of claim. Even if employer did not receive the Iowa Workforce Development decision allowing benefits, the appropriate remedy is not an appeal of the statement of charges. The record developed in this hearing illustrates that the employer has received notice of the claimant's filing of a valid claim for benefits, and it may not appeal the quarterly statement of charges.

DECISION:

The May 9, 2023 statement of charges for the first quarter of 2023 is affirmed.
