Section 96.3-7 - Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

The claimant appealed an unemployment insurance decision dated February 11, 2004, reference 05, that concluded he was overpaid unemployment insurance benefits. A telephone hearing was held on February 25, 2004. The claimant participated in the hearing.

FINDINGS OF FACT:

The claimant filed a new claim for unemployment insurance benefits with an effective date of December 14, 2003. The claimant filed for and received a total of \$728.00 in unemployment insurance benefits for the weeks between December 14, 2003, and January 10, 2004.

The unemployment insurance decision that disqualified the claimant from receiving unemployment insurance benefits has been affirmed in a decision of the administrative law judge in appeal 04A-UI-01131-SWT.

REASONING AND CONCLUSIONS OF LAW:

The issue in this case is whether the claimant was overpaid unemployment insurance benefits.

Iowa Code Section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

Since the decision disqualifying the claimant has been affirmed, the claimant was overpaid \$728.00 in unemployment insurance benefits for the weeks between December 14, 2003, and January 10, 2004.

DECISION:

The unemployment insurance decision dated February 11, 2004, reference 05, is affirmed. The claimant was overpaid \$728.00 in unemployment insurance benefits, which must be repaid.
