ORDER GRANTING POSTPONEMENT

Claimant/appellant, Jennifer Havemann, appealed the reference 02 through 08 decisions, dated January 19, 2023, which denied unemployment insurance benefits.

A telephone hearing, for a total of 22 companion cases, was scheduled for February 15, 2023. On February 7, 2023, claimant's counsel, Nicole Merrill, requested a postponement due to a scheduling conflict. The administrative law judge concludes that good cause has been shown, and accordingly, the claimant's request to postpone is GRANTED. The hearing will be rescheduled for **February 23, 2023**, to begin at **9:00 a.m.**

The parties are reminded that any proposed documents or exhibits must be sent to the UI Appeals Bureau **and** the other two parties. The parties may exchange correspondence and documents via email, fax, or written mail.

For the ease of handling, parties are directed to submit only one hearing packet which will be applied to **all** hearings scheduled with the parties for February 23, 2023. Please do not send multiple sets of exhibits or individual sets of exhibits for individual hearings.

The Iowa Workforce Development Investigation and Recovery Unit is directed to submit proposed exhibits pre-labeled as D-1, D-2, etc.

Any proposed exhibits on behalf of the claimant shall be submitted pre-labeled alphabetically as A, B, C, etc.

Any proposed exhibits on behalf of the employer shall be submitted as E-1, E-2, etc.

The parties are reminded to read **both** sides of the hearing notices and to follow the instructions for participation. Should the parties wish to call witnesses to participate in the hearing, the witnesses should be provided with the administrative law judge's conference line number as it appears on the hearing notice, and witnesses should be directed to call in at the time of the hearing in order to participate.
