Section 96.3-7 – Overpayment of Benefits

STATEMENT OF THE CASE:

The claimant, Benjamin M. Vogel, filed a timely appeal from an unemployment insurance decision dated September 20, 2004 reference 04, determining that the claimant was overpaid unemployment insurance benefits. After due notice was issued, a telephone hearing was held on October 19, 2004, with the claimant participating. This appeal was consolidated with appeal number 04A-UI-10455-RT for the purposes of the hearing with the consent of the parties. Although there was no employer or respondent noticed in this appeal, the employer in the appeal with which this was consolidated, Maze, Inc., participated in the hearing by Ed Threatt, Owner. Carrie Miller was available to testify for the employer but not called because her testimony would have repetitive and unnecessary. The administrative law judge attempted to contact Shelly Snitker to testify for the employer but was unable reach her. The administrative law judge takes official notice of Iowa Workforce Development unemployment insurance records for the claimant.

FINDINGS OF FACT:

Having heard the testimony of the witnesses and having examined all of the evidence in the record, the administrative law judge finds: The claimant filed for unemployment insurance benefits effective August 1, 2004, and began receiving benefits which continued thereafter. The claimant received unemployment insurance benefits in the amount of \$531.00 as follows: \$86.00 for benefit week ending August 7, 2004 (earnings \$25.00) and \$89.00 per week for five weeks from benefit week ending August 14, 2004 to benefit week ending September 11, 2004, in the amount of \$445.00. This amount, \$531.00, is now shown as overpaid and is the subject of this appeal. In appeal number 04A-UI-10455-RT, the administrative law judge concluded that the claimant was not entitled to receive such benefits because his separation from his employer, Maze, Inc., was disqualifying.

REASONING AND CONCLUSIONS OF LAW:

The question presented by this appeal is whether the claimant is overpaid unemployment insurance benefits in the amount of \$531.00 for six weeks between August 1, 2004 and September 11, 2004. The administrative law judge concludes that the claimant is overpaid that amount for that period.

Iowa Code Section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that the claimant has received unemployment insurance benefits in the amount of \$531.00 since separating from the employer herein on or about August 3, 2004 and filing for such benefits effective August 1, 2004. In appeal number 04A-UI-10455-RT, the administrative law judge concluded that the claimant was not entitled to receive such benefits because his separation from his employer, Maze, Inc., was disqualifying. Accordingly, the administrative law judge concludes that the claimant has received unemployment insurance benefits in the amount of \$531.00 to which he is not entitled and he is, therefore, overpaid such benefits. The administrative law judge further concludes that these benefits must be recovered in accordance with the provisions Iowa law.

DECISION:

The representative's decision dated September 20, 2004, reference 04, is affirmed. The claimant, Benjamin M. Vogel, is overpaid unemployment insurance benefits in the amount of \$531.00 for six weeks between August 1, 2004 and September 11, 2004.
