STATEMENT OF THE CASE:

On May 20, 2024, Hardees (employer) filed an appeal from the statement of charges dated May 9, 2024, reference 02, for the first quarter of 2024. A hearing was held on June 12, 2024, pursuant to due notice. Pedro P. Rodriguez (claimant) participated personally. The employer participated through Alex Tischuk, the owner, and Ashlea Kearne, a district manager. Exhibits 1, D1, D2, and D3 were received.

This amendment is being issued to clarify that the separation occurred on April 2, 2023. The previous decision incorrectly stated she separated on April 2, 2024.

ISSUES:

Was the employer's protest timely?
Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

The notice of claim was emailed to Alex Tischuk's email address through the electronic service of notices of claims The State Information Data Exchange System ("SIDES"), atischuck@hotmail.com, on December 11, 2023. The employer protested the claim that same day. He reported that the claimant had quit to take other employment with Iowa Civil Contracting Inc. on April 2, 2023. (Exhibit 1)

The administrative record that displays all decisions related to the claimant does not show a decision was issued regarding the separation on April 2, 2023.

The employer received a statement of charges dated May 9, 2024, for the first quarter of 2024. The statement included a charge for benefits paid to the claimant beginning December 3, 2023. (Exhibit D2) The employer appealed this statement on May 20, 2024. (Exhibit D3)

REASONING AND CONCLUSIONS OF LAW:

The administrative law judge concludes the employer appropriately filed an appeal to the statement of charges because it had previously protested, and no decision was reached regarding that protest.

I am remanding the issue regarding whether this separation disqualifies the claimant from benefits to the Benefits Bureau with due process rights given to both parties.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

- 2. Contribution rates based on benefit experience.
- a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. [Emphasis added.]

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

- 2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:
- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.
- 3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the guarterly statement of benefit charges.
- 4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim

for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

The employer timely protested the notice of claim sent to it electronically. No decision was issued regarding that separation.

The employer then timely appealed the statement of charges on May 20, 2024. This was within the 30-day appeal deadline for statements of charges.

DECISION:

The May 9, 2024, reference 02, statement of charges for the for the first quarter of 2024 is affirmed, pending determination of the remanded issue. The employer timely protested the notice of claim. No decision regarding whether that separation relieved it from benefits or not was issued. The employer then timely appealed the statement of charges.

REMAND:

I remand to the Benefits Bureau to conduct an investigation regarding the issue of whether the separation on April 2, 2023, is disqualifying with due process rights given to both parties.

- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
