Section 96.5-2-a – Discharge for Misconduct

STATEMENT OF THE CASE:

Employer filed an appeal from a decision of a representative dated April 2, 2004, reference 02, which held claimant eligible for unemployment insurance benefits. After due notice, a hearing was scheduled for and held on May 3, 2004 at Des Moines. Claimant participated personally. Employer participated by Joseph G. Bertroche, Sr., Attorney at Law. Exhibits A, B, and One through Six were admitted into evidence.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on August 15, 2003.

Claimant was discharged on August 15, 2003 by employer because of an error made on a foreclosure case that resulted in a \$300,000.00 malpractice allegation by a client. Claimant had tendered his resignation after the error was first discovered. Employer rejected the offer of resignation until after the malpractice issue was resolved in the firm's favor. Claimant was asked by the employer July 15, 2003 to resign. Employer specifically stated that: "it is time for you to tender your resignation." Claimant complied without argument. Initially, claimant wrote a resignation letter indicating that the resignation was made at employer's request. The letter was revised per employer's instructions.

REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether claimant was discharged for misconduct.

Iowa Code Section 96.5-2-a provides:

An individual shall be disqualified for benefits:

2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:

a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

871 IAC 24.32(1)a provides:

Discharge for misconduct.

(1) Definition.

a. "Misconduct" is defined as a deliberate act or omission by a worker which constitutes a material breach of the duties and obligations arising out of such worker's contract of employment. Misconduct as the term is used in the disqualification provision as being limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. On the other hand mere inefficiency, unsatisfactory conduct, failure in good performance as the result of inability or incapacity, inadvertencies or ordinary negligence in isolated instances, or good faith errors in judgment or discretion are not to be deemed misconduct within the meaning of the statute.

This definition has been accepted by the Iowa Supreme Court as accurately reflecting the intent of the legislature. Huntoon v. Iowa Department of Job Service, 275 N.W.2d 445, 448 (Iowa 1979).

871 IAC 24.32(8) provides:

(8) Past acts of misconduct. While past acts and warnings can be used to determine the magnitude of a current act of misconduct, a discharge for misconduct cannot be based on such past act or acts. The termination of employment must be based on a current act.

In this matter, the evidence fails to establish that claimant was discharged for an act of misconduct when claimant violated employer's policy concerning work performance. Claimant was warned concerning this policy. The resignation is a misconduct issue as it was a separation initiated by the employer. Claimant was specifically asked to resign. Claimant's Exhibit B is evidence of a prior resignation letter indicating that the resignation was at employer's request. Quitting in lieu of discharge is a misconduct issue.

The last incident, which brought about the discharge, fails to constitute misconduct because the last incident occurred many months before the resignation was requested. Claimant did make an error in judgment, which would have been misconduct if employer had fired him at that time. Since employer delayed the discharge there is no current act of misconduct on which to base the discharge. The administrative law judge holds that claimant was not discharged for an act of misconduct and, as such, is not disqualified for the receipt of unemployment insurance benefits.

DECISION:

The decision of the representative dated April 2, 2004, reference 02, is affirmed. Claimant is eligible to receive unemployment insurance benefits, provided claimant meets all other eligibility requirements.
