Dismissal of Appeal – 481 Iowa Administrative Code 10.24

**STATEMENT OF THE CASE**

Claimant/Appellant Linda Bryan appealed a decision issued by Respondent Iowa Workforce Development dated March 12, 2015, reference 01, finding Bryan was not eligible to receive unemployment insurance benefits effective March 8, 2015 because she was mailed a notice to report for a reemployment and eligibility assessment on March 11, 2015 and she failed to report.

Iowa Workforce Development transmitted the administrative file to the Department of Inspections and Appeals to schedule a contested case hearing on March 25, 2015. On March 30, 2015, I received an e-mail with attachments requesting the appeal be dismissed because all benefits have been paid. Because the e-mail was sent ex parte, and given it is unclear if the Department provided a copy of all of the documents to Appellant, I am attaching a copy. Because no issues remain for resolution in this administrative appeal, the appeal is dismissed.<sup>1</sup>

### **DECISION**

This appeal is dismissed because no issues remain to be resolved.
