Iowa Code § 96.3(7) - Overpayment of Benefits

STATEMENT OF THE CASE:

The appellant/claimant filed an appeal from the January 2, 2024 (reference 09) unemployment insurance decision that concluded the claimant was overpaid benefits of \$551.00 for the week-ending February 11, 2023. A notice of hearing was mailed to the appellant's last known address of record for a telephone hearing scheduled for January 29, 2024. The claimant participated personally. The administrative law judge took official notice of the claimant's unemployment insurance benefits records.

ISSUE:

Was the claimant overpaid benefits?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: An unemployment insurance decision dated November 30, 2023 (reference 04) had found that the claimant was not eligible for benefits for the week-ending February 11, 2023. The claimant filed an appeal and that decision was affirmed in Appeal No. 24A-UI-00284-DB-T.

Claimant had filed an initial claim for unemployment insurance benefits effective January 8, 2023 following a permanent separation from employment. His weekly benefit amount was \$551.00. During the week-ending February 11, 2023 he received benefits of \$551.00.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes as follows:

Iowa Code section 96.3(7) provides, in pertinent part:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault,

the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5. The employer shall not be relieved of charges if benefits are paid because the employer or an agent of the employer failed to respond timely or adequately to the department's request for information relating to the payment of benefits. This prohibition against relief of charges shall apply to both contributory and reimbursable employers. If the department determines that an employer's failure to respond timely or adequately was due to insufficient notification from the department, the employer's account shall not be charged for the overpayment.

The claimant was paid benefits of \$551.00 for the week-ending February 11, 2023 but then was found to be ineligible for those benefits in a decision dated November 30, 2023 (reference 04). Appeal No. 24AUI-00284-DB-T affirmed that the claimant was not eligible for benefits for the week-ending February 11, 2023. As such, the claimant is overpaid benefits of \$551.00 for the week-ending February 11, 2023 and those benefits shall be repaid to the agency.

DECISION:

The January 2, 2024 (reference 09) unemployment insurance benefits decision is affirmed and remains in effect. The claimant was overpaid benefits of \$551.00 for the week-ending February 11, 2023. Those benefits must be repaid to the agency.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
