## STATEMENT OF THE CASE:

On May 8, 2023, the claimant/appellant filed an appeal from the April 27, 2023, (reference 04) unemployment insurance decision that concluded the claimant was overpaid unemployment insurance benefits in the amount of \$515.00 as a result of incorrectly reporting wages earned with Landus Cooperative. The appellant was properly notified of the hearing. A telephone hearing was held on May 26, 2023. The hearing was held together with appeal 23A-UI-04807-CS-T and combined into one record. The claimant participated. Administrative notice was taken of the claimant's unemployment insurance benefits records.

## **ISSUES:**

- I. Is claimant's appeal timely?
- II. Is the claimant overpaid benefits which must be repaid?

## **FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds: The unemployment insurance decision was mailed to the appellant's address of record on April 27, 2023. The appellant received the decision and the appeal was due Sunday, April 7, 2023. Since the appeal deadline was a Sunday the deadline for the appeal was automatically extended to Monday, April 8, 2023. Claimant filed an appeal on April 8, 2023.

The claimant filed a new claim for unemployment insurance benefits with an effective date of January 22, 2023. Claimant's weekly benefit amount is \$572.00. Claimant began new employment on March 8, 2023. Claimant reported \$200.00 in wages for the week ending March 11, 2023. Claimant received a reduced benefit of \$515.00 in unemployment insurance benefits for the week of March 5, 2023, through March 11, 2023. Claimant actually earned \$829.86 in wages during the week due to starting new employment with Landus Cooperative.

## REASONING AND CONCLUSIONS OF LAW:

The first issue to be considered in this appeal is whether the appellant's appeal is timely. The administrative law judge determines it is.

Iowa Code section 96.6(2) provides:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant. representative shall promptly examine the claim and any protest, take the initiative to ascertain relevant information concerning the claim, and, on the basis of the facts found by the representative, shall determine whether or not the claim is valid. the week with respect to which benefits shall commence, the weekly benefit amount payable and its maximum duration, and whether any disqualification shall be imposed. The claimant has the burden of proving that the claimant meets the basic eligibility conditions of section 96.4. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to section 96.5. except as provided by this subsection. The claimant has the initial burden to produce evidence showing that the claimant is not disqualified for benefits in cases involving section 96.5, subsections 10 and 11, and has the burden of proving that a voluntary quit pursuant to section 96.5, subsection 1, was for good cause attributable to the employer and that the claimant is not disqualified for benefits in cases involving section 96.5, subsection 1, paragraphs "a" through "h". Unless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision. If an administrative law judge affirms a decision of the representative, or the appeal board affirms a decision of the administrative law judge allowing benefits, the benefits shall be paid regardless of any appeal which is thereafter taken, but if the decision is finally reversed, no employer's account shall be charged with benefits so paid and this relief from charges shall apply to both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The appeal deadline for the decision fell on Sunday, April 7, 2023. The decision states: "If this date falls on a Saturday, Sunday, or Legal Holiday, the appeal period is extended to the next working day. Claimant filed the appeal on Monday, April 8, 2023. The appeal is timely.

The next issue that must be determined is whether claimant was overpaid benefits for the week of March 5, 2023, through March 11, 2023. For the reasons that follow the administrative law judge finds the claimant has been overpaid benefits.

Iowa Admin. Code r. 871-24.18 provides:

Wage-earnings limitation. An individual who is partially unemployed may earn weekly a sum equal to the individual's weekly benefit amount plus \$15 before being disqualified for excessive earnings. If such individual earns less than the individual's weekly benefit amount plus \$15, the formula for wage deduction shall be a sum equal to the individual's weekly benefit amount less that part of wages, payable to the individual with respect to

that week and rounded to the lower multiple of one dollar, in excess of one-fourth of the individual's weekly benefit amount.

Iowa Code § 96.3(7) provides, in pertinent part:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

Claimant began new employment on March 8, 2023. The claimant earned more than his weekly benefit amount for the week ending March 11, 2023. As a result, the claimant was overpaid \$515.00 in unemployment insurance benefits for the week of March 5, 2023, through March 11, 2023.

## **DECISION:**

The appeal is timely.

The unemployment insurance decision dated April 27, 2023 (reference 04), is affirmed. The claimant was overpaid \$515.00 in unemployment insurance benefits, which must be repaid.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

#### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
