Section 96.3-7 – Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

Henry Zamora (claimant) appealed representative's March 22, 2006 decision (reference 07) that concluded he had been overpaid \$400.00 in benefits he received for the weeks ending February 25 and March 4, 2006. The overpayment occurred as the result of a representative's March 21 decision that disqualified the claimant from receiving benefits as of February 19, 2006. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on April 17, 2006. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

ISSUE:

Has the claimant been overpaid \$400.00 for the weeks ending February 25 and March 4, 2006?

FINDINGS OF FACT:

The claimant established a claim for unemployment insurance benefits during the week of February 19, 2006. The claimant filed claims for the weeks ending February 25 and March 4, 2006. The claimant received his maximum weekly benefit amount of \$200.00 for each of these weeks.

The claimant appealed the representative's March 21, 2006 decision that disqualified him from receiving benefits as of February 19, 2006. This decision has been reversed. See decision for appeal 06A-UI-03552-DWT.

REASONING AND CONCLUSIONS OF LAW:

If an individual receives benefits he is not legally entitled to receive, the Department shall recover the benefits even if the individual acted in good faith and is not at fault in receiving the overpayment. Iowa Code § 96.3-7. Based on the decision for appeal 06A-UI-03552-DWT, the claimant is legally entitled to receive benefits for the weeks ending February 25 and March 4, 2006. The claimant has not been overpaid \$400.00 in benefits he received for these weeks.

DECISION:

The representative's March 22, 2006 decision (reference 07) is reversed. The claimant is legally entitled to receive benefits for the weeks ending February 25 and March 4, 2006. The claimant has not been overpaid \$400.00 in benefits he received for these weeks.
