871 IAC 24.2(1)e - Failure to Report as Directed

STATEMENT OF THE CASE:

Michael Mecklenburg (claimant) appealed a representative's May 26, 2006 decision (reference 03) that concluded he had failed to respond to a call-in notice and was, therefore, not eligible to receive unemployment insurance benefits. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on June 26, 2006. The claimant participated personally. Exhibits D-1 and D-2 were received into evidence.

FINDINGS OF FACT:

The administrative law judge, having considered all of the evidence in the record, finds that: The Agency mailed a notice to report to the claimant on April 19, 2006, which stated that the

claimant's failure to participate in a telephone interview on April 28, 2006 between 10:00 a.m. and 11:00 a.m., would result in his disqualification for benefits. The claimant was not available and did not provide an alternate number. The interviewer left a message for the claimant indicating he should contact the interviewer by May 11, 2006. The claimant did not respond to the call-in notice by May 28, 2006 at 11:00 a.m.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant failed to report as directed. For the following reasons the administrative law judge concludes he did.

871 IAC 24.2(1)e provides:

e. In order to maintain continuing eligibility for benefits during any continuous period of unemployment, an individual shall report as directed to do so by an authorized representative of the department. If the individual has moved to another locality, the individual may register and report in person at a workforce development center at the time previously specified for the reporting.

The method of reporting and the payment of benefits, provided the individual is otherwise eligible, shall be on a biweekly basis by mail if the claimant files a Form 60-0151.

The method of reporting shall be weekly if a voice response continued claim is filed, unless otherwise directed by an authorized representative of the department. An individual who files a voice response continued claim will have the benefit payment automatically deposited weekly in the individual's financial institution's account or be paid by the mailing of a warrant on a biweekly basis.

In order for an individual to receive payment by direct deposit, the individual must provide the department with the appropriate bank routing code number and a checking or savings account number.

The department retains the ultimate authority to choose the method of reporting and payment.

The claimant was directed to report to the Agency between 10:00 a.m. and 11:00 a.m. on April 28, 2006. The claimant did not respond to the Agency. The Agency gave the claimant until May 28, 2006 to respond, but he did not. When a claimant does not report as directed by a call-in notice, he will not be qualified to receive benefits. The claimant is not eligible to receive unemployment insurance benefits, because he did not respond to the Agency's call-in notice.

DECISION:

The representative's May 26, 2006 decision (reference 03) is affirmed. The claimant is not eligible to receive unemployment insurance benefits because he did not respond to the Agency's call-in notice.
