Section 96.3-7 - Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

The claimant appealed a representative's decision dated September 15, 2004, reference 05, that concluded the claimant was overpaid unemployment insurance benefits in the amount of \$762.00 as a result of a disqualification decision. A telephone hearing was scheduled and held on October 19, 2004, pursuant to due notice. The claimant did participate.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony of the witness and having considered all of the evidence in the record, finds that: The overpayment issue in this case was created by a disqualification decision that has now been modified in favor of the appellant.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that the claimant may be overpaid unemployment insurance benefits pursuant to Iowa Code section 96.3-7 as the disqualification decision that created the overpayment decision has now been modified in favor of the appellant.

DECISION:

The decision of the representative dated September 15, 2004, reference 05, is modified in favor of the appellant. The claimant may be overpaid unemployment insurance benefits for the two-week period from August 1 through August 14, 2004. The issue of the overpayment is remanded to the Claims Section for determination of her weekly benefit amount after the removal of wages earned with Things Remembered from her base period.
