STATEMENT OF THE CASE:

Anthony J. Chia filed appeals from the following decisions issued by Iowa Workforce Development:

Hearing was set for May 27, 2010 at 8:15. Notices of the telephone hearing were sent to Chia at the address supplied to Workforce Development and to Iowa Workforce Development. At the time of hearing Anthony Chia failed to appear. Further, no one appeared on behalf of IWD. I waited five minutes past the time scheduled for hearing, but neither party appeared to participate. This decision is therefore based on the documents contained in the administrative files.

FINDINGS OF FACT:

Claimant Anthony Chia has filed four separate claims for unemployment benefits since 1993. On each the of those claims, IWD issued a decision or decisions finding that Chia had been overpaid benefits due to a failure to report or an incorrect reporting of wages earned while claiming benefits. The decisions are as follows:

Each of the decisions marked with an asterisk above also contained a finding that Chia received the overpayment involved due to misrepresentation on his part.

Each of the eight decisions contained language warning Chia that if he wished to appeal, he must do so within ten days of the date the decision was issued.

Chia filed these appeals with the IWD's Appeals Section on January 29, 2010.

REASONING AND CONCLUSIONS OF LAW:

The first issue is whether the appeals have been filed in a timely manner.

lowa law provides that, unless a claimant files an appeal within ten calendar days after notification of a decision is mailed to him or her, the department's decision regarding the payment of unemployment benefits shall become final.¹

The record in this case shows that far more than ten calendar days elapsed between the mailing date of each decision and the date these appeals were filed. In fact, the most recent decision from which Chia appeals was issued 2 ½ years ago. The lowa Supreme Court has declared the requirement of filing appeals within the time allotted by statute is jurisdictional.² Failure to file a timely appeal deprives the undersigned of authority over the original decision unless there is evidence the claimant was deprived of a reasonable opportunity to file the appeal on a timely basis.³

Chia failed to appear and participate in the hearing on his appeals. He has failed to present any evidence whatsoever that he was prevented in any way from filing timely appeals. Therefore it must be determined that the appeals filed in these cases are not timely and IWD's decisions should remain in full force and effect.

DECISION:

Anthony Chia has failed to file timely appeals from the decisions at issue. The following decisions issued by IWD are **AFFIRMED** and shall remain in full force and effect.
