#### STATEMENT OF THE CASE:

On June 21, 2020, the claimant filed an appeal from the June 15, 2020 (reference 01) unemployment insurance decision that denied benefits to the claimant based on a leave of absence. The parties were properly notified about the hearing. A telephone hearing was held on July 27, 2020. Claimant participated personally. The employer, Walmart Inc., participated through witness Josh Marx. The administrative law judge took official notice of the claimant's unemployment insurance benefits records.

## **ISSUES:**

Is the claimant able to and available for work? Is the claimant on an approved leave of absence?

### FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant has worked for the employer since December 16, 2010. She works full-time as a merchandising team lead. She is still employed with this employer. Claimant's daycare closed down due to the COVID 19 pandemic. Claimant took a voluntary leave of absence due to her lack of daycare, which was approved by the employer. Claimant's leave of absence began on April 21, 2020 and ended June 1, 2020. She is back to work full-time after her leave of absence.

#### **REASONING AND CONCLUSIONS OF LAW:**

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38,

paragraph "b", subparagraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-24.23(10) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(10) The claimant requested and was granted a leave of absence, such period is deemed to be a period of voluntary unemployment and shall be considered ineligible for benefits for such period.

In this case, the claimant notified the employer that she could not work and she was granted a leave of absence. As such, the period of time she is not working is deemed to be a period of voluntary unemployment. Claimant has not established that she is able to and available for work pursuant to lowa Code § 96.4(3). Therefore, claimant is not eligible for regular, state-funded unemployment insurance benefits. Regular unemployment insurance benefits funded by the State of lowa are denied effective April 19, 2020.

#### **DECISION:**

The June 15, 2020 (reference 01) unemployment insurance decision is affirmed. The claimant was on a voluntary leave of absence and is not able to work and available for work effective April 19, 2020. Unemployment insurance benefits funded by the State of Iowa are denied until such time as the claimant is able to and available for work.

This decision denies benefits. If this decision becomes final or if you are not eligible for PUA, you may have an overpayment of benefits.

- If you do not qualify for regular unemployment insurance benefits funded by the State of lowa under state law, you may qualify for benefits under the Federal Pandemic Unemployment Assistance ("PUA") section of the Coronavirus Aid, Relief, and Economic Security Act ("Cares Act") that discusses eligibility for claimants who are unemployed due to the Coronavirus.

Back payments PUA benefits may automatically be used to repay any overpayment of state benefits.
