STATEMENT OF THE CASE:

On January 26, 2024, claimant Craig Larson filed an appeal from the January 16, 2024 (reference 01) unemployment insurance decision that denied benefits after determining that claimant was not eligible for benefits based on wages received in his capacity as an elected official. The Unemployment Insurance Appeals Bureau mailed notice of the hearing on February 7, 2024. Both parties waived notice on the issue of whether the claimant is able to and available for work. Administrative Law Judge Elizabeth A. Johnson held a telephonic hearing at 2:00 p.m. on Tuesday, February 20, 2024. Claimant Craig Larson participated. Employer City of Wesley participated through Stephanie Ricke, City Clerk. The administrative law judge took official notice of the administrative record.

This amended decision is being issued to clarify whether claimant’s position with the City of Wesley is “employment.” Changes have been made in the Reasoning and Conclusions of Law section and the Decision section.

ISSUES:

Is the claimant totally, partially, or temporarily unemployed?
Is the claimant able to and available for work?
Is the employer’s account subject to charge?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

Claimant is the mayor of Wesley, Iowa. He receives \$150.00 per month for this elected position, as required by the Iowa Code.

Claimant also works full-time hours as a truck driver for Reding Gravel & Excavating. He was hired into this position on July 15, 2019. Claimant opened his claim with an effective date of December 17, 2023, when the employer placed him on temporary layoff due to a lack of work. Reding Gravel & Excavating appears on Iowa Workforce Development’s list of employers whose employees are exempt from the work search requirements.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes claimant is still employed in his supplemental elected position.

Iowa Code section 96.1A(37) provides:

"Total and partial unemployment".

a. An individual shall be deemed "totally unemployed" in any week with respect to which no wages are payable to the individual and during which the individual performs no services.

b. An individual shall be deemed partially unemployed in any week in which either of the following apply:

(1) While employed at the individual's then regular job, the individual works less than the regular full-time week and in which the individual earns less than the individual's weekly benefit amount plus fifteen dollars.

(2) The individual, having been separated from the individual's regular job, earns at odd jobs less than the individual's weekly benefit amount plus fifteen dollars.

c. An individual shall be deemed temporarily unemployed if for a period, verified by the department, not to exceed four consecutive weeks, the individual is unemployed due to a plant shutdown, vacation, inventory, lack of work or emergency from the individual's regular job or trade in which the individual worked full-time and will again work full-time, if the individual's employment, although temporarily suspended, has not been terminated.

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.1A, subsection 37, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.1A, subsection 37, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-23.43(4)a provides in part:

(4) Supplemental employment.

a. An individual, who has been separated with cause attributable to the regular employer and who remains in the employ of the individual's part-time, base

period employer, continues to be eligible for benefits as long as the individual is receiving the same employment from the part-time employer that the individual received during the base period. The part-time employer's account, including the reimbursable employer's account, may be relieved of benefit charges....

Iowa Admin. Code r. 871-24.23(26) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(26) Where a claimant is still employed in a part-time job at the same hours and wages as contemplated in the original contract for hire and is not working on a reduced workweek basis different from the contract for hire, such claimant cannot be considered partially unemployed.

Iowa Admin. Code r. 871-23.3(1) and (2)(g) provide in relevant part:

“Wages means all remuneration for personal services, including commissions and bonuses and the cash value of all remuneration in any medium other than cash...”

The term “employment” shall not include wages paid by this state or any of its political subdivisions or by an Indian tribe to: an elected official.


Claimant has primary full-time employment from which he was laid off. Under the definitions set forth in the administrative rules, claimant is not considered employed in his elected position. The wage credits from this position must be deleted.

This matter will be remanded to the Benefits Bureau for further action consistent with this decision.

DECISION:

The January 16, 2024 (reference 01) unemployment insurance decision is modified as follows: Claimant is not considered employed with the City of Wesley. The wage credits attributable to the employer's account (# 102565) must be deleted from the base period.

REMAND: This matter is remanded to the Benefits Bureau of Iowa Workforce Development to review claimant's current employment status with Reding Gravel & Excavating and to release benefits, if appropriate.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

Una decisión de la Junta de Apelaciones de Empleo es una acción final de la agencia. Si una de las partes no está de acuerdo con la decisión de la Junta de Apelación de Empleo, puede presentar una petición de revisión judicial en el tribunal de distrito.

2.
