871 IAC 26.8(1) – Withdrawal of Appeal

STATEMENT OF THE CASE:

The employer filed a timely appeal from an unemployment insurance decision dated March 3, 2005, reference 01, which allowed benefits to the claimant. Due notice was issued for a telephone hearing to be held on February 22, 2005 in Des Moines. Prior to the date of the hearing, the employer requested that the appeal be withdrawn.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: The employer, the appellant in this matter, has requested that the appeal be withdrawn.

REASONING AND CONCLUSIONS OF LAW:

A rule found at 871 IAC 26.8(1) allows the administrative law judge to grant an appellant's request for the withdrawal of its appeal. A review of all matters of record persuades the administrative law judge that it is appropriate to allow the withdrawal of this appeal.

DECISION:

The unemployment insurance decision dated March 3, 2005, reference 01, remains in effect. The claimant is entitled to receive unemployment insurance benefits, provided she is otherwise eligible.
